On 04/07/2018 at approximately 1518 hrs I Ofc Tuang #839 was dispatched to 1212 W Lantana Rd Lantana FL (ACE hardware) in reference a suspicious person. The caller, Inv. Dipolito #827 advised he observed a w/m subject wearing a batman logo t-shirt, smoking, walked into ACE hardware said he was car-jacked and asked to use people's phones then acted suspicious and looking into cars.

I made contact with W/M subject matching the description in front of ACE hardware. He was later identified as Peter Brescia (DOB 06/16/85). Peter advised he lost his phone and trying borrow a phone from someone and his father is waiting for him in the car. Peter then changed his story and advised his father was not waiting for him. Peter then gave me verbal consent to search. Upon search, I retrieved an orange pill bottle (nothing writtin on the bottle) containing .5 mg of Alprazolam from his right pocket. The pill was identified through pill-identifier.

Peter was placed in handcuffs with his hands behind his back (checked for tightness and double locked) and advised that he was being arrested for possession of schedule IV substance.

Probable cause exists to charge Peter Brescia with possession of Schedule IV substance per F.S.S 893.13(6)(A).

Peter was subsequently processed and lodged at the Palm Beach County jail.
