

On Wednesday March 1, 2017 at 18:00 hours I responded to 523 South K Street Apt#1 in the City of Lake Worth FL in reference to a Domestic Battery Investigation.

Upon my arrival I observed a White Male wearing Blue Jeans and a White T-Shirt, Matching the description of the alleged suspect riding his bicycle down South K Street. I exited my P.B.S.O marked Patrol Vehicle I asked the White Male for Identification which he provided and confirmed that he is Peter Mcgaughran who was identified by his Florida ID Card.

I asked Peter if he and his Girlfriend are having problems and he advised that he has been drinking today and that she got mad because he was at the house with another female having a good time and she got mad and started yelling at him for having another female at the house.

I made contact with Brittany Freytag who advised that when she came home from the grocery store she saw Peter drinking a beer in front of the residence with a prostitute. She began to yell at him because he is not supposed to be drinking. She told peter that her father was coming to the house and Peter began to yell and scream and acting aggressive towards her. Brittany Stated "Peter is clearly intoxicated and violent when he drinks so as we were arguing Peter put both his hands on my chest and Violently pushed me against the Wall where I hit my back on the mailboxes." At this time Brittany was terrified because Peter has hit her in the Past. Brittany Stated "I am Terrified of Peter and afraid for my Sons Safety." I observe a large red mark on Brittany's Back which is consistent with her hitting her back against the Wall.

Due to the above aforementioned facts I find Probable Cause to Arrest Peter Mcgaughran for Violation of Florida State Statute 784.03(1)(a)(1). Where Peter did actually and intentionally touch or strike Brittany Freytag against her will during an act of Domestic Violence.
