

(Specifically include facts constituting cause for arrest.)</p> <p>In the City of Riviera Beach, Palm Beach County Florida, the following occurred:</p> <p>On the above date and time Officer McGriff responded to 3691 West Blue Heron Boulevard (Marathon Gas Station) regarding an accident in which one of the parties was armed. The CSA (Civilian Service Aides) who's primary function is to investigate accidents advised that one of the drivers was upset and stated to them that he was armed with a firearm. Based on this information, Officer McGriff responded to the scene for safety.</p> <p>Upon arrival Officer McGriff made contact with a driver who stated that the individual who had a gun had threatened him. The driver, identified as Octavio Gomez (date of birth 1/10/75), stated that after a minor motor vehicle accident within the City limits of Riviera Beach, he was "hailed" to pull over by another driver. Upon doing so, both were exchanging words. Gomez stated that he began to approach the other driver's vehicle in an attempt to view the alleged damage and begin the process of exchanging motor vehicle information for an accident report. In doing so, the secondary driver at this time began to grab his right front pants pocket and stated that he was in possession of a firearm and would "shoot" Gomez. It should be noted that this was the information received via Riviera Beach Communications by the civilian aides, who stated that Gomez indicated that he would shoot the driver for approaching him.</p> <p>Officer McGriff then made contact with the driver and the armed person, identified by his Florida Concealed Weapons Permit (W-1292374) as Peter Fields II (date of birth 4/5/68). Fields was questioned as to the allegations concerning him threatening Gomez as a result of the traffic crash.</p>

Fields stated he was armed with the gun due to Gomez being belligerent and approaching him after the crash. It should be noted that Officer McGriff responded after Officer Elysse (#6346) who retrieved the firearm prior to Officer McGriff's arrival, from his front right pants pocket.</p> <p>Fields privilege to carry a firearm concealed was check via Riviera Beach Communications. A check of his privileges revealed that they were suspended. Fields at this time was placed under arrest and charged with one count of "Carrying a Concealed Firearm" due to his concealed weapons permit being suspended.</p> <p>Fields was transported to the Riviera Beach Police Station for processing, and later to the Palm Beach County Jail for booking.</p>
