# D.U.I. PROBABLE CAUSE AFFIDAVIT

ON THE 9th DAY OF July 20 17, AT 0238 AM PM

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 07/09/2017 at approximately 0246 hours I responded to the area of Foresthill Blvd and Olivetree Blvd, in the City of Greenacres, in reference to a DUI investigation. Upon my arrival I observed a red Mazda CX7 bearing Florida tag RNZ78 stopped facing south on the eastbound travel lanes of Foresthill Blvd. The Mazda had significant front end damage along with airbag deployment (no one was in the vehicle at that time). I observed a red Honda Element bearing Georgia tag BFF3067 stopped in the center median of Foresthill Blvd facing southeast also with significant front end damage and airbag deployment (no one was in the vehicle at that time). Greenacres Fire Rescue was already on scene medically assessing the subjects involved in the crash (run number: 17-2886). I then spoke with Deputy Sanchez about the incident who stated to me the following: The driver of the Honda was escorted out of the car by a witness on scene (Angel Del Rio). The driver of the Honda, identified as Phillip Bradlee Holland through his Georgia Driver's License, stated he was the only one in the vehicle and he was turning left. The driver and passenger of the Mazda, Suvi Manner and Carrieann Preston, were driving eastbound when they were hit. Suvi, the driver, was upset and sitting on the ground. Deputy Sanchez stated that Phillip was not walking normally and his eyes appeared very glassy. He also stated that Phillip swayed when he stood still. I observed Phillip who was standing on the sidewalk at that time.

## OBSERVATION OF DRIVER:

He was wearing a red t-shirt, blue jean pants, and brown shoes. He did not appear to have any noticeable signs of injury sustained during the crash. His face appeared flush and droopy. His eyes were very glassy, red, and droopy. He appeared lethargic and dazed and had a slight circular sway as he stood still. Deputy Sanchez stated that he could not smell any odors other than airbag deployment smell. Deputy Lembo ID:25004 conducted the crash investigation (crash case number: 17100302). I then spoke with Phillip. I asked Phillip for his driver's license which he stated that he did not have it on him. He stated that it could have been in his wallet which was in his vehicle. I asked Phillip if Fire Rescue had already checked him out which he stated they did. They did not advise him of any injuries which required transport to the hospital. Phillip gave crash statements at that time.

## DRIVER'S STATEMENTS:

As he spoke about the crash I could smell the obvious odor of an unknown alcoholic on his breath. His speech was slowed and slurred. I then spoke with Deputy Lembo who advised that the driver of the Mazda may have been DUI as well (see Inv. Levey's DUI report: 17100322). Deputy Sanchez retrieved a sworn written statement from Angel regarding the incident (see attached witness statement for further). (See attached PC Page for further)

Obvious odor of unknown alcoholic beverage on breath as he spoke

## GENERAL OBSERVATIONS

SPEECH: Slurred, slow

ATTITUDE: Calm, compliant, dazed, lethargic

CLOTHING: Red t-shirt, Blue Jeans, Brown Shoes

MEDICAL/OTHER: No medical issues (no diabetes or seizures, stated was told to watch blood sugar because it can be low), no prescription medication or illegal drugs taken, no physical defects or injuries, no issues with eyes (did not wear glasses or contacts), kept shoes on for task

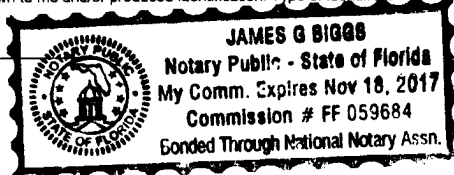

(Specifically include facts constituting cause for arrest.)</p> <p><b>It was determined based on the crash damage and scene evidence that the Mazda was traveling eastbound on Foresthill Blvd when the Honda turned in front of the Mazda. The statement given by Angel confirmed that as well. Angel also stated that he observed the driver of the Honda Element to be "short, caucasian complexion, short brown hair, with an average build." He stated earlier in the statement that the driver was a "he."</b></p> <p><b>I then retrieved Phillip's wallet from his vehicle. The wallet was in the passenger side door pocket of the Honda. I brought the wallet back to Phillip and asked him to retrieve his license. Phillip was slow in finding his license. As I was gaining basic information from Phillip he asked if he was going to jail. No one mentioned he would be going to jail and I informed him the crash investigation was being conducted.</b></p> <p><b>After assisting with the crash investigation I repositioned my patrol vehicle to the parking lot located just south of the crash scene. I asked Phillip to follow me to my patrol vehicle so that I could talk to him. I identified myself to Phillip and advised him that the crash investigation was completed and I was conducting a DUI investigation. I explained that I would have to read him his Constitutional Warnings before speaking about the DUI. I read to Phillip his Constitutional Warnings which he stated he understood.</b></p> <p><b>Post Constitutional Warnings Phillip stated the following: Phillip had no injuries. He stated he looked down and the crash happened. He took a right, was driving west, looked at his phone for 5 seconds, and the crash occurred. He was coming from a venue to his residence. Phillip could not remember the exact venue but stated that one of his friends invited him there. Phillip had been warned about diabetes but was not diagnosed with it. He was told about it six years ago and if his blood sugar gets low he starts shaking. He did not have seizures or any other medical issues. He had no physical defects or injuries, no issues with his eyes that were not corrected by glasses or contacts, and had no speech issues when he talked. He stated that he was driving the Honda which was registered to his father and no one else was in the vehicle with him. Phillip did not have anything to drink since the crash. He stated that he had one drink at the venue two hours prior which was a normal sized beer. Phillip did not take any prescription medications, illegal drugs, or smoked any marijuana.</b></p> <p><b>I explained my concerns to Phillip and asked him to submit to standardized field sobriety tasks. Phillip stated that he would have his parents come pick him up. When I explained I did not ask him that he stated he would do the tasks. Phillip stated he had no physical defects and was able to walk in his shoes. (See Roadside Task Page for further)</b></p>

## Other Observations:

My overhead blue police lights were turned off prior to the tasks. Phillip's eyes tracked equally, the pupils were the same size, were appropriate for the lighting conditions, and no resting nystagmus was observed. Vertical gaze nystagmus was administered and was observed. Lack of convergence was administered and was observed. Both eyes did not converge but stayed straight ahead both times. Phillip swayed side to side during the task and also moved his feet apart.

## WALK &amp; TURN:

I explained and demonstrated the instructions for the walk and turn task to Phillip who stated that he understood. During the task I observed that Phillip had the following cues: couldn't keep balance while listening to instructions (moved right foot off line and raised arms); started too soon; stops walking to steady self/regain balance (stopped walking after missing heel to toe then slide foot back to touch heel and toe); missed heel-to-toe on steps: 1 through 5 and on step 9; stepped off the line on steps: 2, 3, and 9 on first set; used arms for balance (raises arms over six inches); improper turn (at 9th step lost balance and just faced me without attempting instructed turn); did not do return set of steps, stated he was finished after first set; swayed side to side during instructions; stepped on toe on step 6 on first set.

## ONE LEG STAND:

During the instructions for the One Leg Stand task Phillip asked what would happen if he did not do the tasks. I then explained to him Taylor warnings which he stated he understood. I explained and demonstrated the instructions for the one leg stand task to Phillip who stated that he understood. During the task I observed that Phillip had the following cues: swayed while balancing; used arms for balance (raises arms over six inches); put foot down twice (before 30 seconds); did not keep legs straight or look at raised foot.

## FINGER TO NOSE:

I explained and demonstrated the instructions for the finger to nose task to Phillip. I explained what is considered the tip of the finger and tip of the nose to Phillip who stated that he understood. He also knew his left from his right. During the task I observed that Phillip had the following cues: did not keep eyes closed (peeked during task); failed to return arms to the side on each instructed hand; touched bottom of nose before touching tip on 1st through 5th instructed hand; used wrong hand for task (began to raise left when called for right on 5th instructed hand); swayed side to side during task; slow to bring finger to nose.

## ROMBERG ALPHABET:

I explained and demonstrated the instructions for the Romberg with recitation task to Phillip who stated that he understood. I asked him to say his ABCs without stopping and without singing which he stated he could. During the task I observed that Phillip had the following cues: swayed side to side during task. The modified Romberg balance was explained and demonstrated to Phillip who stated that he understood. Phillip was asked to estimate the passage of 30 seconds in their head. Phillip showed the following cues: estimated 35 seconds as 30; stated he counted normally to estimate; swayed side to side during task.

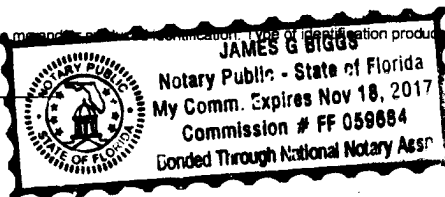
