I arrived on scene a short time later and heard a disturbance coming from inside of apt#421 and was able to make contact with a W/M John Flanagan and a W/F Priscilla Frederiksen.

I first spoke with Flanagan. Flanagan stated that he has been dating Frederiksen for almost two years and lives at the residence with her. He further informed me that they have been arguing a lot lately over relationship issues. Tonight, when Frederiksen returned home from work, the argument escalated while they were arguing in the living room area. During the argument, Frederiksen struck him across his face several times with her closed right fist. Frederiksen then continued to bite Flanagan across his body. Flanagan was visibly upset about the situation and advised that he held her back to keep her from further attacking him.

I observed the injuries to Flanagan's body that appeared fresh. Flanagan was bleeding from his nose and he had a bright red mark above his left eye. Flanagan also had a bite mark on his right arm from Frederiksen.

I took pictures of Flanagan's injuries and submitted them into BRPD Evidence.

I then spoke with Frederiksen. Frederiksen confirmed that the two have been arguing a lot lately and are most likely going to break up soon. Tonight, Frederiksen claims she arrived home after working to 2300 hours. Upon arriving home, Frederiksen says that they began arguing loudly but denied ever physically touching/striking/biting Flanagan. She continued to say that the argument was never physical. She could not explain how Flanagan got his injuries. Frederiksen did not have injuries.

Based on the totality of circumstances, I was able to develop probable cause for simple battery (domestic) based on the fact that Flanagan sustained injuries consistent with his claim that Frederiksen struck and bit him. When taken into account with Frederiksen's statement that she was not involved in a physical altercation and her inability to explain what happened, I placed her under arrest for simple domestic battery per F.S.S. 784.03(1a1).

Frederiksen was transported to the Boca Raton Police Dept. for processing and later taken to the Palm Beach County Jail for final disposition.

Flanagan completed a written statement.
