Probable Cause

On Friday March 2nd, 2018 at approximately 8:40 AM, I was on routine patrol on Interstate 95 (SR9) traveling north merging on from Lantana Road (CR812). I observed a white Hyundai 4 door traveling in the inside lane at a high rate of speed that I estimated to be approximately 95 MPH and occupied by one person. I effected a pace clock on that vehicle and got a speed reading of 91MPH. I got behind the vehicle at 6th Ave and activated my emergency lights and sirens of my marked Florida Highway Patrol vehicle. I attempted to initiate a traffic stop on the vehicle but it continued traveling north with my lights and sirens on behind it. I got another speed reading of 94 MPH while I was directly behind the vehicle. I began to alternate my sirens and move my vehicle to the left and right of the vehicle. The driver finally yielded to my emergency equipment and came to a stop on the median. I identified myself and the reason for the stop to the driver. I was able to smell a strong and distinct odor of marijuana emitting from the vehicle. The driver was identified by FL DL as Racquel Rudolph. I asked Ms. Rudolph if there was anything illegal in the vehicle I needed to know about. She stated yes there is a bowl (smoking pipe) in the back. I asked if there was anything else including edibles. Ms. Rudolph reached to her center console area and retrieved a container which contained a cookie inside. Ms. Rudolph advised me that this cookie was an edible. I could clearly see green substance inside of the cookie. A backup unit was called and Tpr. Petti arrived on scene shortly after. The cookie was field tested and tested positive for marijuana. The cookie was weighed for a total weight of 35.6 grams with a street value of \$712. There was also a multicolored smoking pipe found in the rear floorboard which contained marijuana residue. Ms. Rudolph was placed under lawful arrest for possession of a controlled substance without prescription, public nuisance and possession of paraphernalia. Ms. Rudolph was transported to Palm Beach County Jail by Tpr. Petti. All of the above events occurred within Palm Beach County, State of Florida.


