On the above date and time, I was conducting patrol in the area of 100 NE 13th Avenue. This location is in the City of Boynton Beach, Palm Beach County. While on patrol, I observed a silver 2002 BMW 530i bearing FL tag# Z50BIC, with in inoperable left break light traveling west bound on NE 13th Ave.

The vehicle made a north bound turn onto N. Seacrest Blvd where I effected a traffic stop at the 1400 block of N. Seacrest Blvd. I made contact with the driver and sole occupant of the vehicle W/M Radoslaw Skurzynski (DOB 7/18/84). I asked Skurzynski for his drivers license and vehicle documentation at which time he advised he did not have his drivers license on him. While speaking with the driver, in plain view I observed 3 small white wafer like pieces on top on the center arm rest, through my training and experience appeared to be suspect crack cocaine (0.5 grams). Also in plain view, I observed multiple small pieces of copper wire (chore bore), around the shift stick of the vehicle. Through my training and experience, Chore Bore is commonly used as a filter to smoke crack cocaine. At this time, I asked Skurzynski to step out and he was detained pending further investigation. I conducted a search of the vehicle and gathered the 3 pieces of suspect crack cocaine. I conducted a field test of the suspect narcotics utilizing a NIK Cocaine Wipe. The wipe turned blue confirming the wafer pieces were crack cocaine. At this time I placed Skurzynski in handcuffs, checked for tightness, and double locked them.

Based on the totality of the above listed facts, I find probable cause to charge defendant Radoslaw Skurzynski with possession of crack cocaine pursuant to FSS 893.13.6A

While speaking with Skurzynski, he spontaneously uttered that he had meant an unknown black male in Lantana earlier in the night who advised him to come to NE 12th Ave where he purchased the above narcotics. I conducted a N/FCIC check of Skurzynski yielding negative results for any wants or warrants. Blakes responded to the scene and took possession of the vehicle. The crack cocaine was submitted to BBPD evidence per procedure. Skurzynski received a citation for defective/inoperable equipment. Skurzynski was transported to BBPD for processing and later TOT PBCJ. Nothing further.
