I observed the defendant driving his 2004, blue, Kia Van westbound on Lucerne Avenue. The van had a FL tag of 478PUJ attached. As the defendant neared J Street in the inside lane, the light cycled to red and he began slowing. I observed his seatbelt was not in use and it was hanging against the B pillar. I had been standing outside my vehicle on the southern sidewalk. I approached the driver's side of the vehicle as the defendant lowered a Bud Light Lime beer can to the floor with his right hand. I had him hand it to me and it was 3/4 full, sweating, and cold. He was the only occupant within the vehicle.

OBSERVATION OF DRIVER:

I noticed the driver's eyes were red and glassy. He had a moderate odor of an alcoholic beverage coming from his breath when he spoke to me. I asked him for his license and he initially began handing me a credit card. He then put the credit card away and handed me his license (DL # B200721632420). I had him pull his car to the side of the road. I had him exit the vehicle and I noticed his balance was poor. He had a hard time standing with his feet together and balancing. He had a hard time following directions during the tasks.

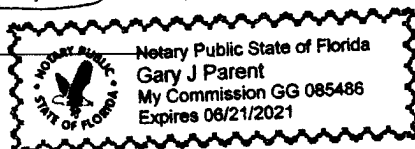

Other Observations:

The defendant had a hard time keeping his head still and he kept moving it when instructed not to. He failed to keep following the stimulus (pen and finger tip). He had to be told numerous times to keep head still and to follow stimulus.
The defendant's eyes were able to converge.

WALK & TURN:

The defendant lost his balance at least three times during the instructions. The defendant missed heel to toe at least three times. He stepped off the line at least one time. He took nine steps forward and turned improperly (he failed to keep his lead foot on the line). He took 11 steps back. He used his arms for balance.

ONE LEG STAND:

The defendant lowered his left leg at least two times during the task. After approximately 19 seconds he lowered his foot for the first time and stopped the task. He had counted to 1010 before lowering his leg the first time. He raised his arms shoulder level for balance. I had to instruct him to begin the task again. He then raised his arms for balance and quickly lowered his leg again.

FINGER TO NOSE:

The task was done as follows: Left1, Right2, Left3, Right4, Right5, Left6. On Left1 he touched the lower portion of his nose below the tip with the pad of his finger. on Right2 he touched below the tip of his nose. On Left3 and Left6 he used the pads of his fingers.

ROMBERG ALPHABET:

The defendant stated the alphabet correctly. He failed to keep his eyes closed.

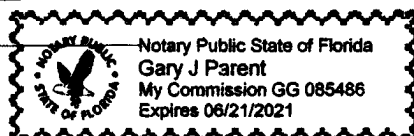
