In the city of Boynton Beach, within the county of Palm Beach, I, Officer D. Wagner, responded to Bermuda Cay, 611 E. Woolbright Ave, in reference to a disturbance.

Upon arrival, I could hear a male yelling and screaming. I knocked on the door which was cracked open, however there was no answer and I continued to hear yelling. I pulled the door open to see w/m Randall Comeau (DOB 04/03/1972) standing in the hallway yelling into the first bedroom. I could hear another male subject crying in the bedroom. I had Comeau step outside with Officer A. Grigorian while I went inside the bedroom to check on the second subject. Inside, w/m John Abbate (DOB 06/18/1975), was sitting on the floor holding his knees and crying. He stated that he called the police after Comeau began kicking his door in to collect rent money. Abbate stated that once Comeau got into his bedroom, he pushed him into the closet and began punching him and kicking him in the head and legs. Abbate had visible redness and swelling to his left ear. Abbate's bedroom door had a large hole in it near the door handle where it was apparently kicked in. Comeau refused to cooperate with our investigation and did not answer any questions.

Based on the aforementioned, I find Probable Cause to charge Comeau with one count of **Domestic Violence Simple Battery** in violation of F.S.S. 784.03.1a1. He was transported to BBPD for processing and later to PBCJ without incident. Photographs of Abbate's injuries and the damaged door were submitted to Adams as evidence.
