On 03/30/2018 I responded to 310 SE Mizner in reference to a possibly impaired driver that was involved in a single car accident involving a 1972 Oldsmobile bearing FL tag#IG1531. The Oldsmobile hit a tree while traveling westbound on SE Mizner.

Jeffery Calabro advised Ofc Rafalko that he saw the accident take place and observed the driver of the Oldsmobile, Randy Sherman exit the vehicle. Calabro advised that Sherman was the only occupant in the vehicle. Ofc Rafalko advised that while he was on scene and was speaking to Sherman, he could smell an odor of an alcoholic beverage emanating from his person, his eyes were blood shot and glossy and Sherman was also slurring his speech. Sherman also told Ofc Rafalko that he went to Hijinks which is a local sports bar but claimed to not have anything to drink.

Ofc Alvarez was also on scene and was responsible for the traffic crash investigation. Ofc Alvarez advised that while speaking with Sherman she could smell a strong odor of an alcoholic beverage emanating from his person, his eyes were blood shot and glossy and he was also slurring his speech. Ofc Alvarez advised that Sherman gave her the wrong address and was also swaying as he talked to her. Ofc Alvarez advised Sherman that she was done conducting her crash investigation and she was now turning over the investigation to me.

I then advised Sherman that I would be conducting a criminal investigation and I read Sherman his Constitutional Rights in the presence of Ofc Rafalko and Ofc Alvarez. Sherman advised that he understood and didn't wish to answer any of my questions pertaining to the traffic crash. While speaking with Sherman I could smell a strong odor of an alcoholic beverage emanating from his person, his eyes were blood shot and glossy and he was slurring his speech. Sherman was also swaying as I read the Miranda Warnings. Based on my observations I asked Sherman if he would submit to the roadside sobriety tasks and he stated no. I then advised Sherman of his Taylor Warnings and


Sherman advised he understood and still refused to submit to the roadside sobriety tasks. I then placed Sherman into custody for DUI. I then transported him to BRPD to be processed.

Ofc Rafalko responded to BRPD as the Breath Test Operator. Ofc Rafalko and I conducted the 20-minute observation and then Sherman was taken into the BAT room. Sherman refused to provide a breath sample. I then read him his Implied Consent Warnings and Sherman advised that he understood and still refused to provide a breath sample. I then asked Sherman if he remembered his Constitutional Rights that I read to him earlier and he stated no and wanted me to read it to him again. I then re-read Sherman his Constitutional Warnings which he advised he understood and he said he wouldn't answer my questions without an attorney present. See DUI influence report.

Sherman is being charged under F.S.S. 316.193(1) for DUI. Sherman was turned over to Palm Beach County Jail for further processing. Sherman's vehicle was towed by Emerald towing.
