On April 17th, 2017 at 2159 hours I was dispatched to 10891 Haydn Dr. Boca Raton, FL 33428 in reference to a domestic dispute. PBSO deputies had previously responded to the residence at 1952 hours earlier today for a domestic dispute reference PBSO case number 17-065820. Upon arrival, I met with the complainant/victim Carlos Llovet who explained the following: His wife Raquel Campos started acting overly aggressive toward him due to their earlier arguments. Raquel pushed him several times in the chest with both arms while screaming at him. He tried to calm Raquel down, but nothing worked. They have a eight year old special needs child together who got very nervous due to her continuous screaming. Raquel also threw books and other items around the residence during the argument. He called 911 due to Raquel showing no sign of calming down. Carlos signed a sworn written statement.

I looked over Carlos who had no visible signs of injury.

I attempted to speak with Raquel about the incident but she refused and began screaming and yelling at deputies on scene. Raquel was very aggressive and was causing a disturbance while I was on scene. It is apparent that Raquel suffers from mental issues.

Due to the information above, I find probable cause to arrest Raquel Campos for Simple Battery per F.S.S. 784.03(1)(a)(1).
