PROBABLE CAUSE

On the above date and time I was dispatched to a crash on the southbound entrance ramp #75. Upon my arrival I approached the crashed vehicles and spoke with the driver of Vehicle 01 later identified as RAQUELIN BERKOWITZ with Florida DL number B-623-720-63-954-0 who was in actual physical control of the vehicle. As I spoke with her I noticed that she had slurred speech and odor of an alcoholic beverage emitting from her. As she spoke it became stronger. I also noticed that her eyes were red and glossy and that she was very lethargic. I tried to have her exit the vehicle and she began to cry and yell that he doesn't love her. When I calmed her down Fire Rescue removed her from the vehicle and transported her to West Boca Medical Center (run number 16-95761 Palm Beach County Fire Rescue 51). Upon my arrival at the hospital I tried to speak with her and she would not wake up. She was passed out. I waited for the hospital to review her medical condition and they released her with no medical issues stopping her from going through a series of Roadside Exercises. I told her that my crash investigation was complete and that due to my observations I was now conducting a criminal DUI investigation. I requested that she do approved roadside exercises so I could look for impairment. She agreed to and all were on FHP0420 in car video

Medical Blood was taken at the hospital by medical personal for medical reasons not at my request*

All exercises were demonstrated and received acknowledgment of understanding prior to requesting her to do them.

Horizontal Gaze Nystagmus

She would not allow me to check her eyes. She would look away from the direction of the stimulus and close her eyes to avoid me looking at them. I did see red, glassy eyes.

Walk and Turn

She was unable to stay in the Instructional stance during the instructional phase. She would lose balance and she would not keep her hands on her side.

When she began the exercise she stopped after 3 steps. She did not walk heel to toe. She could not walk in a forward motion but fell left and right during her steps forward and her steps back. She didn't keep her arms on her side.

One Leg Stand

Arms used for balance, swinging around as if she was on a balance beam. Put leg down and asked to start again with other leg. Started with other leg and put foot down. Could not finish exercise but put foot down. Counts to 1004 and stops. Second try stops at 1007.

I placed her under arrest for suspicion of DUI and I requested a breath test which she refused roadside. I took her to the Palm Beach County Breath Alcohol Testing Center and went on PBSO Video # 61378 where she again refused the test. I delivered her to the Sheriff of the County.

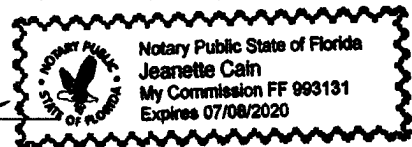
