Officer Boland and I made contact with Crider in the female bathroom that was inside the park. She was coming out of the bathroom stall and had a wad of napkins in her hand. Inside the wad of napkins was a glass pipe, which due to my training and experience is known to be used as a crack pipe to smoke crack cocaine. The pipe was charred on one end and still hot to the touch.

Based on the above facts, Rider is being charged with FSS 893.147(1) Possession and/or Use of Drug Paraphernalia.
