DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Thursday, June 21, 2018 at approximately 2244 hours, I was dispatched to the Foster Shack, located at 2225 Belvedere Road, West Palm Beach (Palm Beach County) Florida in reference to a traffic crash that involved a possible drunk driver. Upon my arrival I noticed several PISO units stopped inside the parking lot of the previously mentioned establishment. A closer observation revealed a white vehicle with severe front end damage stopped in front of a parking space. I saw a white female standing on the passenger side of the vehicle periodically looking inside it. I also saw a gray utility vehicle stopped in the parking lot with damage to its rear side. A Hispanic male was standing in front of it writing a statement. I met with Deputy James Aliseo who investigated the crash. D/S Aliseo directed me to the crash scene and told me the utility vehicle was stopped in the #3 westbound lane of Belvedere Road facing west awaiting the traffic light to cycle green. As the light cycled green a white vehicle struck his vehicle on its rear side with its front side. I saw no tire slide marks on the roadway. I did see a fluid trail leading west toward the intersection of Congress Avenue. D/S Aliseo directed me to the driver of the utility vehicle who was later identified as Joseph Canizares. Canizares gave a sworn video statement informing that he was stopped at the traffic light when a white car struck his vehicle in the back. He got out of the vehicle and saw a white female sitting in the driver seat of the white vehicle trying to smoke a cigarette.

I noticed there were cameras on the south side of the establishment aimed in the direction of the intersection where the crash occurred. I made contact with the manager and asked if she could provide possible video footage that may have captured the crash. The manager asked for a PISO case number with a time frame of the crash occurrence. She told me she would have the owner find the crash and provide a copy to the sheriff's office.

OBSERVATION OF DRIVER:

I made contact with the driver who was standing on the passenger side of the white vehicle with another female subject. She was later identified as Rebecca Jo Enrico by her Delaware driver license. I told her that I was summoned to the scene because the crash investigator had a suspicion she had been drinking an unspecified amount of alcoholic beverages. I told her I am required to read her Miranda Warnings prior to speaking with her. After reading her Miranda I asked if she understood her "rights" she told me she did understand them. During this encounter I noticed her eyes were red, watery and glossy. Her cheeks were flushed and her mouth was dry. I could smell a strong odor of an unknown alcoholic beverage emanating from her breath that intensified when she spoke. I told her I was investigating her for DUI. My suspicion was prompt by the previously mentioned indicators. I asked if she would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if she was impaired while operating a motor vehicle. She refused. I explained Taylor Warnings that informed her performing the SFSTs were voluntary and she did not have to comply. However if she did not comply I would only be left with the evidence before me (previously mentioned indicators) which could be strong basis of her being placed under arrest for DUI. She leaned against her vehicle and began crying. She reached into her vehicle and retrieved a cigarette before facing me. She took an aggressive stand and demanded that I listen to her. I asked if she was willing to cooperate with performing the SFSTs. She continued to be aggressive and did not answer my request. Due to her aggressive nature and lack of cooperation I told her she was being placed under lawful arrest for DUI. She was later handcuffed, double locked and checked for proper fit, prior to being seated into the rear of my patrol car.
