On 10/23/17 Agents of the Palm Beach county Sheriffs Office executed a lawful search warrant at 3885 Edwards Ave, Lake Worth. As a result of the search warrant Agents located 5.9lbs of marijuanan, hashish, and nearly \$4500,00 USC. The defendant Terry Tubbs Jr was arrested for various felonies and remanded to the Palm Beach County Jail.

On 10/24/17 I listened to numerous pre-recorded jail calls from PBSO jail. I identified all outgoing phone calls by defendant Terry Tubbs jr. in which he called his girlfriend Rebekah Moralez at 561-373-1426. During these calls Moralez and Tubbs are discussing items left behind by Agents during the search warrant. Moralez and an unknown male named Randall both talk to Tubbs about the "lean" that we left in the kitchen cabinet. Tubbs speaks to Randall who is possibly the neighbor. Tubbs tells Randall to go check the kitchen cabinet where he keeps his weed and to see if the lean is their. Randall confirms that it is there. Based on my training and experience I know lean to be hydroodone syrup. Moralez also told Tubbs that she still has a wet brownie to which Tubbs replies oh from the red container. Moralez stells Tubbs Agents missed the the thing in the sugar container and the thing in the bathroom, and the think in the cleaning stuff. Terry says oh in the hideway things. Moralez confirms.

On 10/24/17 I authored a warrant that was signed by Judge Glenn Kelley. At 9:16hrs Agents executed a second warrant at 3885 Edwards Ave to retrieve the above items. Upon entering the residence which was unoccupied i located the following :

In the kitchen cabinet where Tubbs stated the lean was I located a babies bottle that contained a reddish purple liquid. The liquid tested field tested positive opiates. The subsistence weighted 81.7g TPW. In the spice cabinet I located the sugar container in which Tubbs and Moralez were talking about. Inside the sugar bottle which was a hideaway bottle I located a plastic bag with brown powder. The bag weighed 8.1grams and field tested positive for Heroin. I then went to the bathroom looking for a hideaway cleaning bottle as indicated by Tubbs and moralez. Underneath the sink I located a blue spray bottle that had a working spray with a hollow bottom. Inside the bottle was a plastic bag with a white rock substance. The substance field tested positive for cocaine.

After executing the second search warrant I again listened to pre-recorded jail calls between Tubbs and Morales. During phone a phone call on 10-24-17 that started at 13:04 Morales tells Tubbs that " they (Agents) found everything, they found the lean." (Hydrocodone syrup) Morales also says "I don't know what else they took because I got rid of the cocaine that was in the thing, I flushed it down the toilet." Tubbs then replies "oh you through away the blow yesterday" and Morales replies "yes I threw away the blow." Tubbs then says "what about the sugar thing" to which Morales replies "I don't see the sugar thing but I know I took it out yesterday," Morales then reads an item off the Inventory receipt that I left along with the search warrant. Morales states " It says they took brown powder" to which Tubbs replies "oh nooooo" Tubbs continues " I can't believe you bro I can't fucking believe you." Morales is now crying saying " I'm sorry Terry. "Tubbs replies "my life is over."
During the search I located a blue plastic spray bottle hideaway can in the bathroom that contained a hidden compartment. Inside the compartment was a small plastic sandwich bag that contained a cocaine rock that weighed .9 grams which field tested positive for cocaine. Morales either lied to Tubbs about flushing it or she flushed some of it and kept a small amount for some unknown reason. In the kitchen cabinet I recovered the sugar hideaway container that Morales states she emptied on 10/23/17. Inside the sugar containers hidden compartment I located a bag of heroin which field tested positive for heroin and weighed 8.1grams. I also recovered the baby bottle in the kitchen cabinet that contained the "lean" which field tested positive for hydrocodone/opiate syrup.
Based on the recovery of the above evidence coupled with the incriminating pre-recorded phone conversations by Tubbs and Morales probable cause exists to believe that Morales had complete control over the items recovered (hydrocodone syrup, cocaine, and heroin) and by her own admission she had knowledge and possession of such items and told Tubbs she took measures to conceal such items knowing a criminal preceding was underway thus tampering with evidence of this criminal investigation, therefore; probable cause exists to charge Morales with Tampering with Evidence per FSS 918.13 (1)(2), trafficking in Heroin 4g-30kg, Trafficking in Hydrocodone per FSS 893.135 1c1, and Possession of Cocaine per FSS 893.13 6a.
