RECEIPT 1 reflected the following information concerning the transaction - 11/09/2019 at 07:01:16AM; 36.810 gallons were pumped from Pump #3 (Diesel) at \$2.699/Gallons; American Express Card ending with 1888 was used to purchase \$99.35 worth of fuel. RECEIPT 2 reflected the following information concerning the transaction - 11/09/2019 at 07:08:54AM; 36.539 gallons were pumped from Pump #3 (Diesel) at \$2.699/Gallons; MasterCard ending with 1888 was used to purchase \$98.75 worth of fuel. A third receipt was produced once the Hispanic male stopped pumping gas. RECEIPT 3 reflected the following information concerning the transaction - 11/09/2019 at 07:13:50AM; 37.051 gallons were pumped from Pump #3 (Diesel) at \$2.699/Gallons; MasterCard ending with 1889 was used to purchase \$100.00 worth of fuel. PROBAB	Corporal Reza and I made contact with the Hispanic male. He was asked if he possessed a Commercial Driver's License. The Hispanic male produced his Florida driver's license allowing us to identify him as Ulloa Valdes, Reinier (W/M/10-30-1982) of 137 W. Browning Drive, West Palm Beach, FL 33406. We also observed he did not have a Commercial Driver's License or any other documents which allowed for him to operate a vehicle on Florida roadways or highways with the large amounts of Diesel fuel he obtained from Wawa. Also during our contact, Ulloa had what appeared to be two credit cards in hand. During the investigative portion of the incident, I asked if I could see the credit cards, and Mr. Ulloa handed them to me freely. The CREDIT CARD is a Bank of America (Visa) credit card ending with the last four digits of The other card is a DEBIT CARD from Bank of America (MasterCard) ending with the last four digits of These card numbers did match the credit card numbers used to purchase the Diesel fuel from Wawa.								
	Corporal Reza and I viewed surveillance video with the store manager - Carlson. We did observe on the surveillance video, the Ford F350 pull into gas pump #3 of the Wawa at approximately 0700hrs. A subject exits the vehicle, and begins the transaction of pumping Diesel gas. That subject was later identified as the Defendant - Reinier Valdes Ulloa.								
	Reinier Valdes Ulloa was placed under arrest for Unlawful Conveyance of Fuel under Florida State Statute 316.80(1). Ulloa was handcuffed to the rear of is person, the handcuffs were doubled locked, and checked for tightness per PBSO General Orders. Ulloa was transported in the rear seat of a PBSO vehicle to District 16, Rough and PC documents were completed, and he was transported to the jail located at 3228 Gun Club Road West Palm Beach, FL 33406 without incident.
