committed the below acts in my presence. was observed by _____ who told _____ that he/she saw the arrested person committ the below acts. admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation.

On the 17 day of March, 2018 at 01:53 (Specifically include facts constituting cause for arrest.)

On 03/17/2018 at 0153 hours, I observed a red Dodge Grand Caravan bearing CA Tag #7WMN578 driving south near the 200 block of N Federal Hwy in Boca Raton, FL. The vehicle had no lights on at night. I conducted a traffic stop at 100 N Federal Hwy and made contact with the driver of the vehicle, W/M Renato Tega. Renato advised he drank two Guinnesses prior to driving. I could smell a strong alcoholic beverage smell emanating from Renato's breath. His eyes were glassy and bloodshot. Renato's speech was slurred and he seemed lethargic. His eyelids were droopy (ptosis) and he displayed a drunk like behavior. At this point I asked Renato to perform some roadside exercises and he complied.

First, Renato conducted the Horizontal Gaze Nystagmus Exercise and he advised he understood my instructions. He displayed a lack of smooth pursuit in the right and left eye. He also displayed a distinct nystagmus at maximum deviation and an onset of nystagmus prior to forty five degrees in the right and left eyes.

Next, I asked Renato to conduct the Walk and Turn exercise. Renato advised he understood my instructions. Renato did not remain in the starting position and he took too many steps. He did not remain on the straight white line and he used his arms to balance. Renato made an improper turn and he did not use heel to toe steps. I had to explain to Renato how to make a proper turn during the exercise.

Lastly, I asked Renato to conduct the one leg stand exercise and he advised he understood my instructions. Renato dropped his foot numerous times and he used his arms to balance.

Based on my training (DRE #028046), experience and the totality of circumstances, Renato was placed under arrest for driving under the influence. I transported him to the Boca
