## NARRATIVE:

On 07/28/2017 I responded to 218 South Federal Highway, Unit 1 in the City of Lake Worth, Palm Beach County, Florida in reference to a domestic dispute.

Upon arrival, I observed multiple items such as papers and office supplies thrown on the ground of the first floor near the entrance door. I made contact with a white female who identified herself as Rene Abrams. Abrams advised me she was in a dispute with her boyfriend of four years but she did not contact the police. I asked Abrams where her boyfriend, James Lovley was and she said he is probably in the house or may have left. I located Lovley and also spoke with him.

I spoke with Abrams to ask her what happened. While speaking with Abrams, I smelled a heavy odor of an unknown alcoholic beverage on her breathe and asked her if she had been drinking. Abrams admitted to having been drinking beers this evening. Abrams stated she got into a verbal dispute with Lovley when she got home later (after she took a shower) due to her not answering his text messages. The dispute got heated and they agreed they will separate and she demanded he write her a check and give her his vehicle. At this point Abrams stated she grabbed his checkbook and wrote a check in her name on Lovley's check because he refused. Abrams claimed after she wrote the check Lovley grabbed her using both hands around her neck and pushed her. Abrams stated as she walked away Lovley grabbed her again using both hands and choked her around the neck with both hands for approximately 12 seconds at which point she could not breathe for several seconds and then he pushed her on the ground where she fell back and hit her head on the ground. Abrams stated at this

point Lovley contacted police. It should be noted that there were inconsistencies in statement including the amount she drank, sequence of events, how much she wrote the checks for, etc.



I also spoke with Lovley who has had tracheotomy and a stomach pump. As a result, Lovley has difficulty speaking and has to use one of his hands to cover his neck when he speaks. Lovley advised me he got into a verbal dispute with Abrams when she came home because she was not answering her phone. The dispute became heated and Abrams stated she was leaving and demanded money and Lovley's vehicle.

R.R. her Lovley refused to write Abrams a check so she grabbed his check and wrote a check in his name for \$70,000.00. Lovley stated he peacefully grabbed the checkbook back from Abrams. Lovley stated as a result, Abrams came after him to grab the checkbook and began tugging on it as he tugged back on the checkbook.

While tugging on the checkbook, they both tripped and ended up against the wall. At this point Abrams was attacking Lovley trying to fight him and pushed him. Lovley did not recall other specific details of the fight. At this point he was using one hand to hold his throat to tell her to calm down while using his other arm to defend himself by holding her back. Lovley stated Abrams continued acting "crazy" and began throwing items in the room such as office supplies that were on the table at him and he was hit with unknown objects at this time. Lovley stated she continued destroying the room and when he tried to grab the phone to call the police she pulled the plug out of the phone line and he was able to plug the phone back in to call the police. At this point, Lovley stated she calmed down, laid on the ground and started making false accusations against him while he was on the phone with the police.

I examined both subjects for injuries. Abrams did not have any injuries around her neck consistent with being choked twice. She was not bleeding and did not have any other visible injuries. Lovley stated he did not have any injuries either. It should be noted that Lovley was sober and provided a consistent statement.

Based on my investigation, Abrams is in violation of F.S.S 784.03(1), Simple Battery (Domestic Violence).
