The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. On the 28TH day of MARCH 2018 at 8:10 P.M. (Specifically include facts constituting cause for arrest.)

On the above date and time I responded to 10579 BOBBIE LN, Royal Palm Beach FL 33411 in reference to a domestic, in progress. Upon arrival I met with the victim William McCreedy (W/M 04/14/1962) who I immediately saw to be emotionally upset. William immediately stated to me that "she bit me" and then proceeded to show me his right forearm that displayed two red circular bite marks with a small amount of blood drawn. William stated that it all began when his 'ex-girlfriend', Rene Ann Papi, that resides in the same home, who he has dated within the past six (6) months, came home intoxicated around 7 PM that night. He stated that Rene began to immediately argue with him about how he treats her dogs. He stated that he went to his bedroom to get away from her and she followed him, breaking the door and began to fight with him, biting him twice on the arm and kicking him between the legs. William stated that at this time he shoved her off of him and went to hide inside the bathroom where she also broke that door too. Sworn verbal statements were taken from the victim from my in-car video recording system that corroborates the above made statements. The bite marks were consistent with his statements. During my investigation I noticed that William had to circular bite marks on his right forearm that were still red and swollen. He complained that the two bite marks severely hurt initially and he could still feel the pain. I was then able to then locate Rene Papi inside the residence to which she immediately stated that "he was a fucking asshole", to which I noticed that he speech was slurred. When asked during my fact finding discussion Rene spontaneously stated to me and other deputies that she bit him because he was "holding her dog hostage". While speaking with her about the argument that night she also stated that she was going to "kill him and take out his organs", she also yelled in the direction of William while being taken into custody "I am going to fucking kill you" DART photos were taken by D/S J. Landa (#20328) and uploaded to the PBSO domestic violence website. Based on the above facts of the case and statements provided, I find defendant Rene Papi to be in violation of Florida State Statute 784.03(1)(A)(1) for unlawfully touching or striking William McCreedy against her will.
