NARRATIVE:

On November 9, 2016, at approximately 1550 hours, D/S Gutierrez of the Palm Beach County Sheriff's Office responded to 22258 Waterside Dr. Boca Raton, Florida in reference to a theft complaint. Upon arriving at the above location D/S Gutierrez met with the victim/complainant identified as Stephen De Peralta. Stephen stated that his wife Karina Musella had witnessed their babysitter Renee Sonnet, via a live internet feed from a security camera stealing approximately \$220.00 in U.S. currency. The currency was located inside an envelope located in a computer desk. Renee Sonnet was confronted by both Stephen and Karina regarding the missing currency. Renee initially denied taking any money but then admitted that she had taken \$220.00 from the envelope earlier that day. Karina Musella further advised that additional monies had been stolen approximately one week earlier where Renee Sonnet had admitted to taking a small amount of cash.

After determining that Renee Sonnet had stolen several hundred dollars in cash, Karina Musella believed that Renee was a possible suspect responsible for stealing other missing jewelry from the residence. Karina Musella initially believed that the missing jewelry items were misplaced during a recent move. Karina Musella reported several wristwatches were unaccounted for with full descriptions of make and models provided to the Sheriff's Office. Karina Musella did not authorize anyone to remove property from her residence or to sell any items to a pawnshop.

Based on the information provided by the victim a search of the pawnshop database was conducted which revealed an individual identified as Renee Sonnet had sold two

watches that matched the description provided by the victim. Further review of records from the RAPID pawnshop system from June 7, 2016, revealed that Renee Sonnet had sold two watches to include a Tag Heuer and a Daniel Mink to Value Pawn & Jewelry located at 1401 S. Military Trail, West Palm Beach, Florida which is within the jurisdictional boundaries of Palm Beach County, Florida.

Based upon the above information, I made contact with Value Pawn & Jewelry employee Willis Lopez, who told me the Daniel Mink watch was sold and the Tag Heuer watch was still in his possession. Arrangements were made to physically inspect the Tag Heuer watch at Value Pawn & Jewelry. The watch was determined to be a match based on the description provided by the victim. The victim reported the watch to have a white face with three blue sub-dials, a rotating bezel, stainless steel case, and an imitation black crocodile band which had stress marks located at the junction points where the watch was secured on a daily basis. All of these factors coupled with the complete description and unique markings of the band assisted the victim in making a positive identification. Mr. Lopez filled out a sworn Pawn Shop Affidavit attesting to the fact that Renee Sonnet was responsible for completing the sale of the above mentioned watch on June 7, 2016.

According to Pawnbroker Transaction Form 1335000 it was determined that the suspect Renee Sonnet had sold the Tag Heuer watch on June 7, 2016, at approximately 6:12 p.m. Sonnet received a monetary benefit in the amount of \$200.00. Examination of the Pawnbroker Transaction Form indicates that the pledgor/seller identified herself as Renee Sonnet with a DOB of 02-03-81. Sonnet listed her home address as 2607 Arbor Lane West Palm Beach, Florida 33411. A Florida driver's license number of S530-732-81-543-1 was utilized to complete the transaction. A review of the Florida Driver and Vehicle Information Database reveals that this license is issued to Renee Sonnet with the above mentioned date of birth and previous address. At the bottom of the Pawnbroker Transaction Form Renee Sonnet signed under the pledgor/seller indicating that the property that was sold was not rented or leased and that there were no liens or encumbrances against them. Sonnet indicated that she was the rightful owner of the pledged property and that she has the right to sell the pledged property. Subsequent to the transaction being completed, a thumb print of the suspect Renee Sonnet was obtained and placed at the bottom right hand side of the form.

On January 23, 2017, I went to the residence of the victim Karina Musella along with Detective Michael Valenti for the purpose of conducting a photo line-up. Detective Valenti asked Ms. Musella to review a photo line-up in an attempt to identify the suspect Renee Sonnet. Detective Valenti showed Ms. Musella a group of six photographs which were all similar in nature and characteristics. Without hesitation Ms. Musella made a positive identification of the suspect Renee Sonnet who was located in




the number three position. Ms. Musella verified that this was in fact the same person who she had hired as a babysitter and was personally known to her for several months.

On April 5, 2017, arrangements were made to meet with Renee Sonnet in reference to this investigation. At approximately 1530 hours I met with a female who subsequently identified herself as Renee Sonnet outside Trader Joe's located at 2877 S State Rd 7, Wellington, FL 33414. I told Renee Sonnet that she was the subject of an on-going criminal investigation regarding a theft that occurred from the victim Karina Musella. I immediately advised Renee Sonnet of her constitutional rights which she signed and waived. Renee Sonnet provided a sworn written statement stating " In June 2016, I worked for a family and took a watch and pawned it at Palm Beach Value Pawn. It was a Tag watch. The owners didn't give me permission to take it". Ms. Sonnet did not provide any other information and denied taking any money or other items from the residence.

Investigation to date reveals that the suspect Renee Sonnet stole a Tag Heuer watch from the residence of Karina Musella located at 22258 Waterside Dr. Boca Raton, FL 33428. Renee Sonnet was hired as a babysitter to care for the victim's young child and had access to all areas of the residence. The victim reported the theft of a Tag Heuer watch after becoming suspicious of Ms. Sonnet regarding missing money. RAPID records were reviewed which verified that the suspect Renee Sonnet had sold the stolen Tag Heuer watch to a local pawnshop in West Palm Beach, Florida where she received a monetary benefit in the amount of \$200.00. Renee Sonnet was interviewed and post Miranda admitted to stealing the watch and selling it to Value Pawn & Jewelry in West Palm Beach without the authorization of the victim.

Based on the facts developed in this investigation Renee Sonnet is being arrested and charged with one count of Dealing in Stolen Property in violation of Florida State Statute 812.019(1) and one count of False Verification of Ownership < \$300.00 in violation of Florida State Statute 539.001(8b)(8a).
