Prior to arriving, _____ contacted the business reception number of 561-729-4998 via text message, on 02/09/2017 and asked for an appointment for 1pm 02/09/2017. minutes later _____ received a message from 561-201-2810 aka Linda (Rhonda), and arranged the appointment for 1pm. _____ entered suite 3 once inside the businesses which was clearly marked and advertised therapeutic massages and spa. Once inside _____ made contact with Rhonda Robinson-Scheelk whom he had an appointment with and Layla Miranda. _____ asked if Layla was available as well and Rhonda stated she was. While speaking to them _____ asked if Layla spoke english and they both stated yes. _____ then asked if the both will get naked during the massage and if they will both provide oral and sexual intercourse. Rhonda stated "no" but they will both give him a happy ending. _____ while making a sexual hand gesture then asked will they both stroke me, at the same time and Rhonda stated yes. _____ asked them what would something like that cost him and Rhonda replied we just did one for \$200.00 dollars, so that was the agreed upon amount. _____ advised that Layla was standing next to Rhonda, during the negotiation and that he made eye contact with Layla during the negotiation the entire time. Based on the aforementioned, probable cause exists to charge both Rhonda Robinson-Scheelk and Layla Miranda with violation of F.S.S. 796.07(2)e, Offer to commit Prostitution, per Florida State Statute.</p> <p>On scene we had _____ who advised us that both females did not have or ever had a valid "Massage therapist License". Based on those facts there is probable cause to charge them both with violation of F.S.S 480.047 ( 1a) Regulations of professions and occupation (Impersonating a massage therapist), it is unlawful to hold himself or herself as a massage therapist or to practice massage unlicensed. _____ of the transaction were burned to a CD and placed into evidence for trial purposes by _____. Both subjects were placed into PBSO issued handcuffs which were double locked and checked for fit and transported to the Palm Beach County Jail.</p>
