PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the above date and time, I responded to Deputy Schneider #8723 who conducted a traffic stop at the intersection of Equestrian Drive and Lake Worth Road in the Village of Wellington on a vehicle for unlawful speed. Deputy Schneider requested me after making contact with the driver as he suspected the driver may have been impaired and wanted me to conduct a DUI investigation. Upon my arrival, I observed Deputy Schneider's marked patrol car with its emergency overhead lights activated and parked behind a white Cadillac Escalade bearing Florida tag "EZMV87". I exited my vehicle and met with Deputy Schneider who told me the following, "on the above date and time I was conducting speed enforcement utilizing stationary radar in the area of 12900 Lake Worth Road, Village of Wellington, PBSO Patrol District 8. My PBSO marked patrol unit was facing west when I observed a vehicle approaching me at a high rate of speed. I visually estimated the speed at approximately 60 mph and upon activation of my PBSO assigned radar unit I received a loud doppler tone and confirmed the speed on radar at 58 mph. I initiated a traffic stop by activating my emergency lights. At that time the driver did not pull to the right and stop the vehicle, instead they pulled into the center turn lane. OBSERVATION OF DRIVER:

After receiving the identification card from Deputy Schneider, I approached the vehicle on the driver's side and made contact with the driver who verbally identified himself as Ricardo Carrizo. I asked the driver if he had a valid drivers license because he handed Deputy Schneider his identification card and he stated "no, my license was suspended in a previous DUI case. I confirmed Carrizo's identity via his valid identification card. I observed Carrizo was wearing blue jean pants and black T-shirt shirt. While questioning Carrizo, I observed that he seemed nervous and had both hands on the steering wheel with a tight grip with both hands. I asked Carrizo if he knew why he was stopped and he answered "yes, I was stopped for speeding". While Carrizo was speaking, I observed his eyes appeared red and glassy. Carrizo was asked to exit his vehicle to perform field sobriety tasks which he agreed to. While exiting the vehicle, Carrizo appeared to be shaky on his feet. I directed Carrizo to the other side of a raised median near the entrance to the Equestrian Club entrance. The area I directed Carrizo to was a safe location away from traffic and was a level surface for conducting field sobriety tasks. Once in front of my vehicle, I observed Driver was swaying while he stood with both feet together.

DRIVER'S STATEMENTS:

I asked if Carrizo if he had been drinking or used any drugs and he stated he had one drink of gin and tonic. I asked Carrizo if and what medical problems and/or previous injuries he had and he stated he did not have any. I asked Carrizo if he wore any glasses or contacts and he answered "no". I asked Carrizo if he was prescribed any medications and if so what and he answered "no medication".



Other Observations:

I read and demonstrated the instructions of the HGN while Carrizo was placed in the instructed position. During this task, I explained to Carrizo to put both feet together and his hands down by his side. I asked him to keep head still and to look at the stimulus with his eyes only. I told him to keep looking at the stimulus until told the test is over. I asked him to not move his head and finally asked if he understood. Carrizo stated he understood and throughout task I had to tell him twice to not turn his head as he followed the stimulus.

WALK & TURN:

I read and demonstrated the instructions of the walk and turn while Carrizo was placed in the instructed position. While explaining the task I observed Carrizo was swaying and would not maintain his arms by his side. After explaining the instructions, I asked Carrizo if he understood the instructions and he said "yes". During the task, I observed Carrizo swayed while balancing, stopped walking to steady himself, did not touch heel to toe throughout task and stepped off the line three times. Carrizo used his arms to maintain balance, did not turn properly and lost his balance while turning causing him to stagger.

ONE LEG STAND:

I read and demonstrated the instructions of the one leg stand while Carrizo was placed into the instructional position. Once in this position, I observed Carrizo was swaying while I explained task. When I asked if he understood the instructions, He answered "yes". During the task, I observed Carrizo swayed while balancing, appeared shaky on his feet, did not keep both arms down by his side and placed his foot down twice within 30 seconds.

FINGER TO NOSE:

I read and demonstrated the instruction of the finger to nose task while Carrizo was placed in the instructional position, while doing so Carrizo placed his head back and attempted to start the task prior to the conclusion of my instructions. Carrizo was told to return to the instructional position and to observe me while I explained the task. Carrizo stated he understood the instructions. Prior to starting task, I observed Carrizo continued to sway. Carrizo completed task. Only indicator detected was starting too early while in the instructional position.

ROMBERG ALPHABET:

I read the instruction of the Romberg alphabet with recitation task while Carrizo was placed in the instructional position. Carrizo tilted his head back and attempted to start task prior to being told to do so. Carrizo stated he understood the instructions and proceeded to complete task as requested.

If you fail to submit to the test I have requested of you, your privilege to operate a motor vehicle will be suspended for a period of one (1) year for a first refusal, or eighteen (18) months if your privilege has been previously suspended as a result of a refusal to submit to a lawful test of your breath, urine or blood. Additionally, if you refuse to submit to the test I have requested of you and if your driving privilege has been previously suspended for a prior refusal to submit to a lawful test of your breath, urine or blood, you will be committing a misdemeanor. Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
