


OFC Schneider began to travel to the residence from Heights Park located at 15221 Reville Cir N, Jupiter, FL 33458.</p> <p>OFC Schneider said he was going to travel north on Greenway Dr from Soriano Dr, there was a silver Chevrolet Silverado bearing FL tag GDXT74 directly in front of him also turning north on Greenway Dr from Soriano Dr. OFC Schneider observed the aforementioned vehicle weaving in the northbound lane immediately after it turned onto Greenway Dr. OFC Schneider observed the vehicle commit several traffic violations to include running a stop sign and crossing the solid white lines of the bicycle lane. The vehicle again committed two more lane violations, before it turned north on Indian Creek Parkway from Greenway Dr.</p> <p>OFC Schneider told me that he initiated a traffic stop on Indian Creek Parkway in front of Jupiter First Church located at 1475 Indian Creek Parkway, Jupiter, FL 33458. OFC Schneider said he conducted a passenger side approach and made contact with the sole occupant and driver identified by his Florida Driver License as Richard C Chase (wm; 01/01/1981). OFC Schneider advised Chase that he pulled him over because he crossed over the solid white line and did not come to a complete stop. OFC Schneider said he asked Chase for the registration and insurance. Chase dropped his registration while he handed it to OFC Schneider. OFC Schneider said that Chase advised he just left his brother's house, but did not remember exactly where it was. Chase appeared tired and his eyes were droopy. OFC Schneider asked Chase if he had anything to drink at his brother's house and he said he had two drinks. OFC Schneider observed a clear mason jar with approximately two inches of an unknown liquid in it in the cup holder of the center console. OFC Schneider asked Chase what was in the jar and he stated it was "booze". OFC Schneider said that as he was speaking with Chase his overall demeanor seemed slow and</p>

<p>his speech was very slow and slurred. I arrived on scene a few moments later to conduct a DUI investigation. OFC Schneider completed a supplemental report.</p> <p>I made contact with Chase at the driver side window. As Chase spoke to me I detected an odor of an unknown alcoholic substance coming from his person. The odor intensified as he kept talking with me. Chase told me that he was at his brother-in-law's home where he was moving furniture, and while there he had a shot of "Jägermeister". I asked Chase if he thought he was impaired and he said "Not so much". I asked Chase if he thought he should be driving and he told me "more than likely not". I then asked Chase to step out of the vehicle. I had him go to the rear of his vehicle where I asked him a few more questions. I asked Chase that on a scale 1 to 10 how impaired he thought he was and he told me "5". I asked Chase if he was willing to complete roadside sobriety tasks and he agreed.</p> <p>I observed the following on the roadsides. HGN, I observed lack of smooth pursuit in both eyes, distinct and sustained nystagmus at max deviation in both eyes, and onset of nystagmus prior to 45 degrees. VGN, I observed distinct and sustained nystagmus at max deviation. Walk and Turn, I observed Chase start too soon, he could not keep balance while listening to instructions, he took 10 steps instead of 9 on his first set of steps, he failed to touch heel to toe on several steps (three times on his first set of steps), he stepped off the line, and failed to complete the turn as he was instructed. The One leg stand, I observed swaying while balancing and Chase put his foot down. The Finger to nose touch I observed the following, L1 - touched the pad of finger to tip of nose, R1 - touched the side of the finger to the side of nose, L2 - touched the pad of the finger to the tip of the nose, R2 - touched the pad of finger to the tip of nose, R3 - first raised left hand slightly and the used right hand to touch the side of the finger to the top of his nose, L3 - touched the pad of the finger to the top of his nose. Romberg test I observed him count from 20 to 46 properly, he swayed while in position.</p> <p>Upon completion of the roadside tasks I placed Chase under arrest for DUI and informed him. I secured Chase in handcuffs, which I checked for spacing and double locked. I placed Chase in the back of my police car and retrieved his personal property from his vehicle. In his vehicle I observed a mason jar filled with an unknown liquid. The liquid had a strong odor of alcohol.</p> <p>I then transported Chase to the Palm Beach County Breath Alcohol Testing Facility. I conducted a 20 minute observation period to ensure that Chase did not take anything by mouth or regurgitate. I then requested Chase provide a sample of his breath. He agreed immediately. Chase provided two samples of .118 and .122. I read Chase his Miranda Rights from a prepared text. Chase invoked his rights. I secured Chase in a holding cell and completed my paperwork. I subsequently booked Chase into the Palm Beach County Jail where I charged him with DUI per FSS 316.193(1).</p>
