P R O B A B L E C A U S E S T A T E M E N T	On 11/30/19 at approximately 0230 I responded as backup to Officer Kenniston on a traffic stop at 7299 N.W. 2nd Ave. Upon my arrival I observed a W/M to be sitting in the driver's seat of a 2013 White Dodge Challenger. Officer Kenniston advised me that he had conducted a traffic stop on this vehicle and believed the driver to be under the influence of alcohol and/or narcotics. I introduced myself to the driver and he identified himself as Richard Wolflick, although he stated he prefers to be called "Chadd". While speaking with him, he appeared to be extremely intoxicated. His speech was slurred and he had a strong odor of alcohol emitting from his breath and his eyes were glassy and bloodshot. I asked where he was heading and he advised "home". He advised he was coming from taking care of a house in "way West Boca", then stated East Boca at the Boca Resort because he was at a party there. He then stated that his brother had died and he became emotional. His moods were unstable and changed quickly, consistent with someone under the influence of alcohol.						
	I advised him that I believed him to be under the influence of alcohol and requested that he submit to a series of tasks to determine his level of impairment. He stated he would submit to this series of tasks. He then exited his vehicle and we moved to a flat, level surface. Upon exiting his vehicle, he had difficulty standing. He had to lean against the car in order to keep his balance. I asked what his highest level of education was and he advised he had a PHD in Engineering. I asked him if he had any physical ailments and he advised he did with his back. When asked what the issues with his back were, he advised "A lot".						
	Task one was the Horizontal Gaze Nystagmus. He was instructed how to stand during the exercise and he advised he understood. He advised he did not have any problems with his eyes other than him requiring glasses or contact lenses. He exhibited lack of smooth pursuit with both eyes. There was distinct and sustained Nystagmus at maximum deviation in both eyes and there was onset of Nystagmus prior to 45 degrees in both eyes. He had

difficulty standing and was swaying approximately 6 inches side to side. He could not follow the directions and moved his head several times and failed to follow the stimulus. In addition, he had to be told several times to place his feet together. At one point he spontaneously stated "My ass". When asked what he meant, he advised "Never mind". Task two was the walk and turn. I explained the instructions to the suspect and ensured that he understood them prior to beginning. I explained to him how to stand in the starting position, however he had difficulty doing that and stated he was unable to stand on the line. He advised he had been stabbed and was taking care of dogs so he might have a hard time completing the task. Upon beginning, he failed to place his feet in the starting position. He then took three steps, stepping off the line approximately a foot on each step. He requested to start over barefoot which he was allowed to. He stayed on the line for three steps, however he did not count them out loud. Upon completing his third step, he stated "give me another test". This test was stopped at his request. Task three was the one leg stand. I explained the instructions to the suspect and made sure he understood them prior to beginning. The suspect failed to keep his feet together in the starting position. When asked if he understood the directions, he stated "absolutely" in an enthusiastic manner. He then asked if he could hold on to my car for this task, which I advised would not be permitted. I asked if he felt able to perform this task he stated he did. He then requested I explain the instructions again, which I did for him and I demonstrated the task again. He failed to keep his feet together. He raised his left foot approximately 12 inches straight up by bending his knee, counted one-one thousand and then put his foot down and stated he could not complete the task. This task was stopped at that point. Task four was the finger to nose (L, L, R, L, R, R, L). I explained the instructions to the suspect and he advised he understood them prior to beginning. Upon beginning, the suspect did not have his feet together. He first touched the tip of his right finger to his cheek just left of his nose, then corrected by touching his left fingertip to the bridge of his nose. He then touched his left fingertip to his nose and left it there. He was reminded after approximately 20 seconds that he was supposed to return his finger to his side after touching his nose. He was reminded multiple times during this task to stand with his feet together due to him not correctly following the instructions. He then touched the right tip of his finger to his nose and left it there once again, not removing it until the next direction was given. He then touched the tip of his nose with his left finger and left it there until the next direction was given. He then touched the tip of his nose with his right finger and left it there until the next direction was given. He then touched the tip of his nose with his left finger rather than the right, however he corrected himself. He was swaying several inches during this task from side

to side. Task five was the Romberg without Recitation. I explained the task to the suspect and he advised he understood the instructions prior to beginning. I used my watch to show the suspect thirty seconds prior to beginning. He then asked if he could use his fingers to help him count, and was told that would not be permitted. The suspect ended the task at forty-one seconds and was swaying approximately 3-6 inches during the task. The suspect was then placed in handcuffs and was advised he was being arrested for Driving Under the Influence. The defendant was issued warning citation #1182043 for improper start and Florida Uniform DUI Citation A6LQ9IE with a mandatory court date of January 7, 2020 at 0830 hours at the South County Courthouse in Delray Beach. The defendant's vehicle was towed from the scene by Westway.
