
On Friday the 15th day of September, 2017, at approximately 2315hrs I arrived at 1331 S. Federal Hwy Apt. 519 (Las Ventanas) in reference to a disturbance. Upon my arrival I met with Erica Cooley who advised she had an unwanted guest (Richard J. Morgan) and became scared when he wouldn't leave when asked. Erica stated that she is not dating Richard is has simply been friends with him for a couple years. Erica went on to say that this evening she had been asking Richard to leave and he simply would not. Erica stated that at some point she did not feel safe and called her boyfriend (James P. Novick) for advice.

Erica stated that when she called James he happened to be on his way home. It should be noted that James lives just down the hall way on the same floor of the same building as Erica. Erica stated that James told her to go to his apartment and wait for him. When James arrived, minutes later, he made his way towards Erica's apartment (# 544) and saw the door closing as he was approaching with Richard inside; James then entered. When speaking with James he stated that when he made contact with Richard he told him he had to leave. James identified himself as Erica's boyfriend and stated that he was not welcome at the apartment.

Due to a considerable size difference and Richards hostility, James grabbed a kitchen knife all the while purposefully keeping distance from Richard. Richard was advancing towards James and saying something to the effect of "you don't want to fight an English bloke" displaying machismo. James stated that Richard kept coming at him while having his hands up in a boxing stance all the while advising. James stated that while in the hallway of the building Richard closed the distance and pushed him to the ground. James stated he was able to quickly get up and make it to his apartment where Erica was and lock the door then calling the police from within. Both Erica and James stated that Richard was then banging on James' door until the police arrived.

James sustained a small laceration to his right thumb during the altercation; medical attention was refused. Photographs of both Richard and James were obtained and submitted into the electronic B.B.P.D. evidence database (A.D.A.M.S.) via the remote program Digital Acquire. Erica did not witness the battery. James provided a sworn written statement captured on my AXON body worn camera stating that he wanted to press charges and was willing to testify in court. Based on the above facts, I find probable cause to charge Richard with Simple Battery in accordance with F.S.S. 784.03(1)(a)(1). James was provided with a victims rights pamphlet along with the case number. Both Erica and James were advised not to hesitate in contacting the B.B.P.D. in the future should any assistance be needed.

Due to the fact that Richard's residence is in Dade county he was transported to the B.B.P.D. for processing and once cleared from having any active wants or warrants his care and custody was turned over to the Palm Beach County Jail.
