

PROBABLE CAUSE	<p>On 9/21/2016, Officer Bissoon advised of a suspicious vehicle in the parking lot of 1200 West Yamato Road, Boca Raton, Florida. Myself and Officer Calhoun arrived at 0117 hours.</p> <p>I observed a silver Honda parked in a parking space. The headlights were on and the engine was running. The windows were fogged up. I walked up to the driver's door and observed subject, Richard Baron in the driver's seat. He was found lying forward over the steering wheel. I opened the unlocked driver's door and attempted to wake him up. I provided verbal words to wake up and tugged at his left arm. He finally woke up and yelled "fuck" "fuck".</p> <p>I asked him if he was okay and he stated yes. I asked if he had any medical conditions and he stated no. He takes no medications and has no physical impairments. He told me he had nothing to drink tonight.</p> <p>While I was speaking with him, I could smell a strong odor of an alcoholic beverage coming from his breath. His eyes were red and glassy. His speech was slurred. I asked him to exit the vehicle. When he did, he stumbled back. I then turned off the vehicle and removed the key.</p> <p>I asked him to walk to the front of my vehicle. He was swaying and walking slowly. I explained my observations and asked him if he would attempt the road side tasks. He finally agreed to attempt the tasks.</p> <p>The first task was the horizontal gaze nystagmus. There was a lack of smooth pursuit in each eye. Distinct and sustained nystagmus at maximum deviation in each eye. Onset of nystagmus prior to 45 degrees in each eye. He was swaying side to side while standing.</p>

<p>The second task was the walk and turn. He left the starting position. He started before he was instructed. He was not counting out loud. He did not touch heel to toe on each step. He walked more then 9 steps out. He did not turn as instructed and then stopped before walking back. He walked more then 9 steps back.</p> <p>The third task was the one leg stand. He raised his right leg. He bent his knee back. He was swaying and using his arms. He was not looking at his raised foot. He dropped his foot to the ground and then stopped.</p> <p>The fourth task was the finger to nose (L-R-L-R-R-L). He missed the tip of his nose on each movement. He was attempting to use his middle finger. On the 5th he raised his left before correcting. He was swaying side to side at times.</p> <p>The fifth task was the romberg/alphabet. He was swaying side to side at times. He sang through the letters. He was unable to complete the letters in order.</p> <p>At 0144 hours, I placed him under arrest. The vehicle was removed by Westway Towing. I transported him to The BRPD.</p> <p>I conducted The Intoxilyzer 8000 testing. I asked him to provide a breath sample. He stated, I ain't doing shit. I read him Implied Consent. He had no questions. I asked him again to provide a breath sample and he stated I see no reason for that. At 0234 hours, he was issued a refusal. He has a prior refusal from Palm Beach County on 1/12/2009.</p> <p>He was charged with DUI FSS 316.193(1) and Refusing a Chemical Test with a Prior Refusal FSS 316.1939(1). 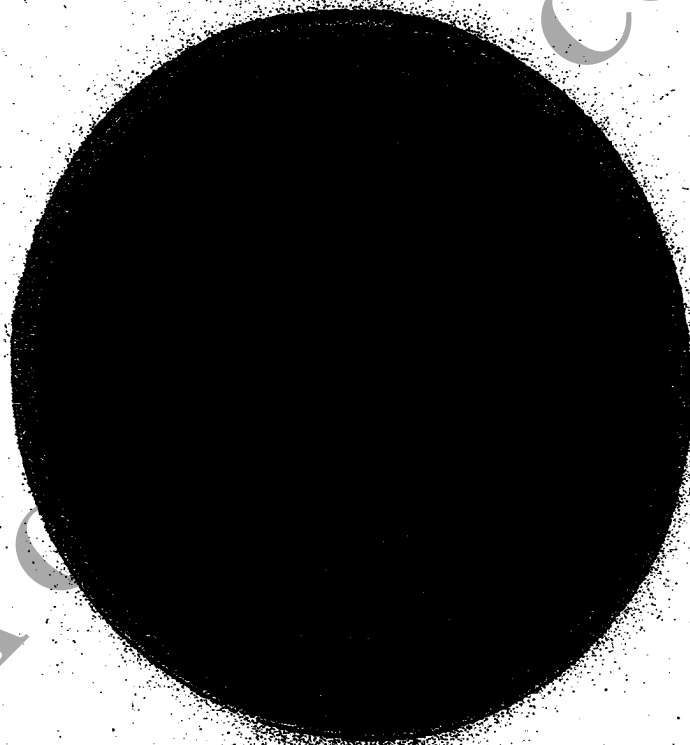
