# D.U.I. PROBABLE CAUSE AFFIDAVIT

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Saturday, December 9, 2017 at approximately 0005 hours, I was dispatched to Big Blue Trace, north of South Shore Boulevard, Wellington (Palm Beach County) Florida to assist Deputy Daniel Mercier with a traffic stop that involved a possible drunk driver. Upon my arrival I noticed D/S Mercier's patrol car stopped in the southbound lane with its emergency lights activated. D/S J Dehl was also on scene as a back up officer. A blue vehicle was in front of the patrol cars. I made contact with D/S Mercier who told me the following regarding his traffic stop: On Saturday 12/9/17, I was on routine patrol in the Village of Wellington, Palm Beach County, Florida. I was leaving an unrelated call near Wellington Trace and Via Veneto, when I saw a small blue car traveling west on Wellington Trace at an estimated 100 mph. I caught up to the vehicle bearing FL tag CBBL64 (assigned to the defendant's other vehicle), as it slowed and turned onto Big Blue Trace. As we traveled south on Big Blue, I paced the defendant at 88mph in a 40 mph zone. I initiated a traffic stop in the 1700 block of Big Blue Trace.

I made contact with the WM driver / sole occupant and identified him by FL DL as RICHARD JOSEPH PELLEGRINI JR. The defendant had red, watery, bloodshot eyes, and slurred speech. He looked "dazed" and fumbled with his paperwork, dropped his wallet and his license, before handing them to me. When asked about his speed, he said he was going to remove a rat from a clients house. When asked how much he had had to drink, he said nothing, then said "one beer a long time ago."

Based on these observations, I called for a DUI unit to conduct a possible DUI investigation. Investigator Keith White arrived and I turned the investigation over to him: D/S Mercier cited the driver for excessive speed.

## OBSERVATION OF DRIVER:

I made contact with the driver who was standing at the rear of his vehicle. He was later identified as Richard Joseph Pellegrini Jr. by his Florida driver license. During my interview I noticed his eyes were red, watery and glossy. His speech was slow and slightly slurred. His mouth was dry and cheeks were flushed. He was unsteady on his feet while standing and had trouble keeping his balance. I could smell a strong odor of an unknown alcoholic beverage emanating from his breath that intensified when he spoke to me. I explained to the driver that I had a suspicion he had been drinking an unspecified amount of unknown alcoholic beverages. He told me he drank one glass of wine with his dinner. He also told me he was not drunk and I could "breathalyze" him if needed. He explained he was speeding because of a pest control job that he was trying to respond to. I asked if he would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if he was impaired while operating a motor vehicle. He consented to performing the SFSTs. I asked if he had any physical problems with his body that would inhibit him from performing light physical movements. I also asked if he was on medication. The defendant conveyed he has 11 titanium screws inside his left ankle and five (5) herniated disk (three in his neck and back). He is taking roxycodone and oxycotin. I asked what was his duties while working. He explained he crawls through small places and well as climb when necessary. I escorted him to a smooth and level surface that was free from obstructions and debris. The area was well lighted by the lights from my patrol car. I asked him to identify with the white edge line on the roadway. He successfully did so by placing his left foot on the line when asked. The following SFSTs were explained, demonstrated and acknowledged by him prior to his performance: HGN, The Walk and Turn, The One Leg Stand, The Finger to Nose and The Romberg Alphabet Recitation. His deficiencies were recorded on another form on this worksheet. At the conclusion of the SFSTs, coupled with D/S Mercier's observation of the defendant's vehicle in motion and my observation of personal indicators of impairment exhibited by the defendant, probable cause was established for DUI.

## DRIVER'S STATEMENTS:

I drank one glass of wine with dinner. I am not drunk you can give me a breath test.

## ODORS:

STRONG ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE COMING FROM SUBJECT'S BREATH.

## GENERAL OBSERVATIONS

SPEECH: slow and slightly slurred

ATTITUDE: confident non believing

CLOTHING: blue tank top, gray slacks and white and red loafers

MEDICAL/OTHER: herniated disc and ankle

**HORIZONTAL GAZE NYSTAGMUS:**

- LT EYE-LACK OF SMOOTH PURSUIT
- RT EYE-LACK OF SMOOTH PURSUIT
- LT EYE-DISTINCT & SUSTAINED NYSTAGMUS AT MAX. DEVIATION

**Other Observations:**

Subject was asked to stand with their feet together and place their hands by their side. They were asked to focus on the stimulus and follow it with their eyes. Lastly they were told not to move their head to assist in following the stimulus with their eyes. Subject showed equal pupil size that tracked equally. Both eyes lacked a smooth pursuit. I saw distinct and sustained Nystagmus at maximum deviation. I also saw an onset of Nystagmus prior to 45 degrees in both eyes. Subject swayed while performing this task.

**WALK & TURN:**

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE WALK AND TURN. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject was unable to maintain his balance while placed in the instructional position. He trembled and ultimately lost his balance, causing him to abandoned the position all together. During the task he could not maintain his balance while walking on the line. He stopped to steady himself. He turned improperly and stepped off the line.

**ONE LEG STAND:**

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE ONE LEG STAND. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject was unable to maintain his balance while leg/foot was elevated. He began trembling and counter leaning in an effort to maintain his balance. He dropped his foot on the roadway three (3) times. I decided to stop this task for safety concerns

**FINGER TO NOSE:**

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE FINGER TO NOSE. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject swayed while performing this task. He failed to touch the tip of his finger to the tip of his nose on all six attempts. Rather he touched the side and bridge of his nose. On occasion he searched for the tip of his nose. He flinched the wrong hand for this task on one occasion.

**ROMBERG ALPHABET:**

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE ROMBERG ALPHABET TASK. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject swayed while performing this task. He failed to recite the 26 letter alphabet.
