

victim, [REDACTED] provided Officer Sanchez with a sworn account of what had transpired. [REDACTED] reported that she is married to Richard Morsch, however they are currently separated. They have a daughter (eight years-old) who was a witness to the event. She reported that her and her daughter arrived at Richard's residence at approximately 9:30 p.m. to drop off her daughter and stay the night so they could spend Christmas together. When she entered his house, she noticed an empty bottle of wine that Richard had drank and did not feel comfortable staying there and leaving her daughter. After [REDACTED] unloaded the Christmas presents from her car, she attempted to leave through the laundry room. Inside the laundry room [REDACTED] stated Richard got in her face and told her that she is not leaving. [REDACTED] told Richard to get out of her face at which point he grabbed her by the shoulders and pushed her into the garage against his parked vehicle. Richard pushed [REDACTED] again into her vehicle located just outside the open garage. [REDACTED] stated Richard pushed her a third time in the driveway which caused her to fall to the ground at which point Mr. Shaw (neighbor from across the street) came outside and assisted [REDACTED] into his residence. See Officer Sanchez's supplemental report for more information.

[REDACTED] sustained a laceration and swelling to her right wrist and was complaining of back pain. Palm Beach County Fire Rescue arrived on scene and treated [REDACTED] for her injuries. [REDACTED] refused being transported to the hospital for further evaluation.

Officer Carver made contact with Mr. Shaw who provided a sworn verbal statement advising the following: he arrived home with his wife when heard what sounded like people yelling across the street. As he approached their residence, he witnessed [REDACTED] fall off her car onto the ground as Richard stood over top of her screaming and cursing. While this was taking place, their daughter, [REDACTED] was witnessed screaming at her dad to get away.

Upon my arrival, I made contact with the male half, identified as Richard Morsch, who was immediately detained and read his Miranda Rights from a pre-printed card in my presence by Sergeant Beath. Morsch stated he understood his rights and was asked to state what occurred tonight. Post-Miranda, Morsch advised he was supposed to spend Christmas Eve with his daughter around 7:00 p.m. but could not get ahold of his wife, [REDACTED]

At approximately 10:00 p.m. [REDACTED] arrived at the residence and did not speak to Richard. Richard stated when he began questioning [REDACTED] as to why she did not answer her phone and why she came so late she became very aggressive. A verbal argument began between both parties because [REDACTED] did not understand why Richard always needs to have their daughter on Christmas Eve. Richard stated [REDACTED] began walking to the garage and while inside the garage she became "physically aggressive". When Richard was asked to elaborate how she was physically aggressive, he stated she began to walk towards him in an aggressive manner at which point he grabbed her by the arm and attempted to escort her out of the garage. While holding onto her, Richard stated [REDACTED] began "flailing" her arms around while yelling. Richard said he escorted her outside the garage, but she tripped on the ledge and fell against her vehicle in the driveway. [REDACTED] then laid in the driveway as he said he tried helping her up and asked if she was hurt. At this point, Richard's neighbor, Richard Shaw, came outside and assisted [REDACTED] into his residence. It should be noted that [REDACTED]'s account of the events was not consistent. Though he reported that she was walking toward him, he also stated that she was walking backward from the garage. He also could not account for his neighbor's depiction of him standing over his wife yelling obscenities.

Officer Carver made contact with [REDACTED], and asked her what happened. [REDACTED] stated her dad started arguing with

mom when they got home. As her mom walked into the garage, dad followed and threw her against his car inside the garage, then threw her on her car in the driveway, and then threw her onto the ground. When asked if she saw this take place, [REDACTED] said she did not see it take place, but her mom told her that's what happened. [REDACTED] did state that she specifically witnessed her dad push mom to the ground outside.

Based on the above facts and circumstances, Richard Morsch was placed under arrest and is charged with domestic battery in violation of F.S.S. 784.03(1)(A)(1). Richard was transported to Palm Beach County Jail where he was booked under this charge. This incident was recorded on my Palm Beach Gardens Police Department issued body worn camera and uploaded to evidence.com. All corresponding videos were properly tagged and marked.
