

<p><b>I responded to 2121 Shimmery Lane, unincorporated Lantana, Palm Beach County in reference to a simple battery.</b></p>										
<p><b>I made contact with the defendant, Richard Puccio, who stated to me that he was struck in the head by the Victim [REDACTED] with a gun. The defendant was checked by PBC Fire Rescue Eng 35 (17008273) for the cut to the top of his head and to his ear.</b></p>										
<p><b>I made contact with the victim, [REDACTED] He stated to me that he was in the garage area with Puccio, who was visiting from New York, who kept apologizing. When he told Puccio that he didn't have to keep apologizing, Puccio became angry and it became a verbal argument. [REDACTED] stated that Puccio brought his arm back like he was going to strike him. A neighbor heard the yelling and came over and started video taping the incident. [REDACTED] tried to back away and go inside where Puccio followed him. They went up stairs by the bedroom where Puccio tried to punch [REDACTED] multiple times. As Puccio's momentum took him towards [REDACTED] struck him once in the back of the head with a elbow. [REDACTED] then continued to try to separate himself by going into his and his girlfriend's, (Puccio's daughter) room.</b></p>										
<p><b>I watched the video that was taken by the neighbor, Travon Walker. On the video you can see Puccio in the garage aggressively yelling at [REDACTED]. Puccio was moving towards [REDACTED] and [REDACTED] was trying to move backwards. [REDACTED] then goes inside and the video goes black but you can still hear the Audio and the yelling. Once they reach the top of the stairs you can again see Puccio being aggressive and moving towards. [REDACTED] is standing in a defensive fighting stance but does not swing towards Puccio.</b></p>										
<p><b>Peyton Puccio, who completed a written sworn statement stated that her father was screaming at [REDACTED] and the proceeded to get in his face. She stated that her father then started swinging at [REDACTED]. She stated that [REDACTED] does not have a gun and there is not a gun in the house.</b></p>										
<p><b>Based on my investigation I found that Puccios was the predominate aggressor in the this case. I found probable cause to arrest the defendant for simple battery pursuant to Florida State Statute 784.03(1A1).</b></p>
