DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)
ON 11/11/16 AT APPROXIMATELY 0105 HOURS I WAS CONDUCTING STATIONARY TRAFFIC ENFORCEMENT WITH INV. C. FICARRA #8368 IN THE 9000 BLOCK OF NORTHLAKE BLVD, IN THE CITY OF WEST PALM BEACH. AS I WAS FACING EAST IN THE MEDIAN, I OBSERVED A VEHICLE COME OVER THE BRIDGE. I ESTIMATED THAT THAT VEHICLE WAS TRAVELING 77 MPH IN A POSTED 55MPH ZONE. AS I LOOKED AT MY RADAR UNIT, I HEARD THE TONE AND VISUAL INDICATOR OF 80 MPH. SHORTLY AFTER I OBSERVED ANOTHER VEHICLE COMING OVER THE BRIDGE. I ESTIMATED THAT THIS VEHICLE WAS TRAVELING IN EXCESS OF 105 MPH. AS I LOOKED BACK AT MY RADAR UNIT, I HEARD THE TONE AND VISUAL READING OF 109 MPH IN A POSTED 55 MPH ZONE. AS I PULLED OUT BEHIND THE VEHICLE DOING 109 MPH, BEING A SILVER KIA BEARING FL TAG OF AFKC62. AS I ACTIVED MY OVERHEAD LIGHTS AND SIREN THE VEHICLE CAME TO A STOP WEST OF MY STATIONARY LOCATION.

OBSERVATION OF DRIVER:

AS I EXITED MY PATROL VEHICLE, I APPROACHED THE VEHICLE. I OBSERVED THAT IT WAS OCCUPIED ONE TIME, BY THE DRIVER. I OBSERVED THAT HE WAS WEARING A BLUE DRESS SHIRT, BLACK SLACKS, AND TAN DRESS SHOES. I OBSERVED THAT HIS EYES WERE GLASSY, BLOOD SHOT, AND WATERY. I INFORMED THE DRIVER WHY HE WAS BEING STOPPED, AND HOW FAST BOTH HE AND THE OTHER VEHICLE WERE GOING. THE DRIVER WAS LATER IDENTIFIED AS RICHARD SCANLON BY HIS IRELAND DRIVING PERMIT, AND CONFIRMED IN THE DRIVER AND VEHICLE INFORMATION DATABASE. I WAS ABLE TO LOCATE HIS FLORIDA DRIVER'S LICENSE NUMBER IN THE SYSTEM. HIS SPEECH WAS SLURRED, SLOW, PRONOUNCED, AND WITH AN IRISH ACCENT.



Other Observations:

The overhead forward facing blue police lights were turned off prior to beginning the task. Richard's eyes tracked equally, the pupils were the same size and appropriate for the lighting conditions, and no resting nystagmus was observed. Richard had difficulty following the stimulus and not moving his head. I had to have him hold his chin, to prevent his head from moving. Vertical gaze nystagmus was administered and was not observed. Lack of convergence was administered and was not observed.

WALK & TURN:

I explained and demonstrated the instructions for the walk and turn task to Richard who stated that he understood. During the task I observed that Richard had the following cues: couldn't keep balance while listening to instructions; started too soon; stops walking to steady self; missed heel-to-toe on several steps; improper turn (loses balance, and removed both feet from line to make turn)

ONE LEG STAND:

I explained and demonstrated the instructions for the one leg stand task to Richard who stated that he understood. During the task I observed that Richard had the following cues: swayed while balancing;

FINGER TO NOSE:

I explained and demonstrated the instructions for the finger to nose task to Richard I explained what is considered the tip of the finger and tip of the nose to Richard who stated that he understood.

The task was conducted with the following results. L - touched inside right nostril; R - pad to left side of nose; L - tip to tip; R - pad to tip; R - pad to tip; L - touched right nostril.

ROMBERG ALPHABET:

Prior to beginning the task, I confirmed what level of education Richard had completed. He stated that they had a masters degree, and is familiar with the English alphabet. I explained and demonstrated the instructions for the Romberg with recitation task to Richard who stated that he understood. He said "A,B,C,D,E,F,G,H,I,J,K,L,M,N,O,C,Q,R,S,T,U,V,W,X,Y,Zed,U,V"

Richard was asked to estimate the passage of 30 seconds in their head. Richard estimated from 01:24:57 - 01:25:53 as 30 (thirty) seconds. Richard was also swaying while conducting the task.




