The undersigned certifies and swears that he/she has just and resonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. On the 20 day of January, 2018 at 01:17

On the above date at approximately 0117 hours I was traveling through the parking lot at 6671 West Indiantown Road in reference to responding to a shoplifting call that had just been dispatched nearby.

As I traveled south in front of the business, Uncle Mick's, I observed a black 2016 Dodge pickup bearing Texas License Plate JCN0199 backing up towards the west out of an adjacent style parking space.

I noticed minor damage to the front bumper of the grey pickup in the exact spot I saw the vehicles make contact with each other. Sharpe's vehicle did not have any visible damage.

Upon completion of my crash investigation, I read Sharpe his Miranda Rights from a prepared text, which he indicated he understood. I asked Sharpe what happened, with his rights in mind.

During Horizontal Gaze Nystagmus, Sharpe was swaying visibly. Sharpe had great difficulty following the stimulus and keeping his head still. I observed lack of smooth

pursuit in both eyes but was unable to complete the task due to Sharpe's patent inability to follow the instructions and keep his head still.

I then began the Walk and Turn task. Sharpe had great difficulty following my instructions to get in the starting position. Sharpe did not appear to realize his left foot was in front of his right foot. Sharpe started to correct his feet and lost his balance, stumbling to the right and taking several steps to regain his balance. Sharpe then declared he was, "done". I then advised Sharpe of his Taylor Warnings. Sharpe indicated he wanted to continue. Sharpe lost his balance from the starting position several times. Sharpe indicated he understood the instructions. Sharpe took two steps, missing heel to toe on the second step. Sharpe then lost his balance to the right and took several steps to recover his balance. Sharpe said that he "missed". I asked Sharpe to continue. Sharpe indicated I was, "freaking" him out and was reticent to continue. I reminded Sharpe of the Taylor Warnings. Sharpe continued to prevaricate and did not restart or continue the task. Sharpe then said, "do whatever you gotta do". I took that as a refusal to continue.

Based on the totality of my investigation and observations, I placed Sharpe under arrest for DUI. I secured Sharpe in handcuffs, which I checked for spacing and double locked. I transported Sharpe to the Palm Beach County Breath Alcohol Testing Facility. Sharpe asked to call an attorney during transport. I advised Sharpe he did not have the right to do so at that point in the process. I conducted a 20 minute observation period with Sharpe. I asked Sharpe to provide a sample of his breath. He refused. I read Sharpe Implied Consent from a prepared text. Sharpe needed clarification and I further explained Implied Consent. Sharpe agreed to provide a sample. Sharpe then refused to provide a sample. Sharpe again had difficulty making a decision and prevaricated. Sharpe eventually refused to provide a sample after I advised him that not making a decision would not be taken as a refusal. Sharpe indicated spontaneously that he had consumed five beers and then asked to provide a sample to "just see". I did not conduct an interview due to Sharpe's indications that he wanted a lawyer.

I secured Sharpe in a holding cell while I completed my paperwork. Upon completion, I booked Sharpe into the Palm Beach County Jail where I charged him with DUI with Property Damage per FSS 316.193(3)(C)(1).

This incident was captured on my issued Body Worn Camera. Officer Kitchens also had his BWC activated.
