	Officer Burnette stated that Michele was one of the drivers involved in the crash. Her husband, Richard, arrived shortly after and while speaking with Michele, kicked her with his right leg and made contact with Michele's left leg around the shin area.								
	I then spoke with both Michele and Richard, separately, who both advised the following: during the traffic crash investigation Michele and Richard were speaking. Richard then struck Michele in the left shin/calf area with his right foot. Richard advised that he kicked Michele because she was "talking too much." I did not observe any physical injuries or markings to Michele's leg.								
C A U S E	Following my investigation, I placed Richard under arrest for domestic battery under FSS 784.03(1). He was transported to BRPD booking for processing and then TOT CJ.
