I responded to Macy's Department Store 801 North Congress Avenue in reference to a Retail Theft. Upon arrival I made contact with Loss Prevention Officer Marissa Zalinger who advised a h/f, later identified as Roberlys Barbara Bravo Mesa was in their custody inside the Loss prevention Office. Zalinger advised while conducting CCTV Surveillance she observed Bravo select multiple clothing items and enter a pre-cleaned fitting room. Zalinger then observed Bravo exit the fitting rooms without the merchandise, at which time Zalinger checked the fitting room and was unable to locate the merchandise, but did locate several merchandise tags. Then while continuing to conduct floor surveillance of Bravo, Zalinger observed Bravo select three men's Under Armor shirts and enter a different pre-cleaned fitting room. Bravo exited shortly after with only two of the three Under Armor shirts visible, at which time a check of this fitting room yielded negative results of the merchandise. Bravo then exited Macy's through the West exit/entrance passing all points of sale, making no attempt to pay for the merchandise concealed in her purse. Bravo was approached and detained by Loss Prevention at which time Zalinger recovered 8 clothing items. The amount of merchandise recovered was \$331.95.

Zalinger completed a sworn written statement and provided me with an itemized receipt which was submitted to BBPD Records. Zalinger advised Macy's would provide the video surveillance at a later date.

Zalinger was cleared for all wants and warrants via FCIC/NCIC.

Due to the above facts, I find Probable Cause to charge Bravo with Grand Retail Theft per F.S.S. 812.014(2)(c)(1). Bravo was taken to BBPD Booking for processing and TOT PBCJ.
