On Tuesday October 10, 2017 between 1200 to 2000hrs, I participated in a group operation throughout the unincorporated Boca Raton, Palm Beach County Florida, to combat street level prostitution.

Female deputy sheriffs were posing as prostitutes in various locations. The locations were chosen due to recent citizen's complaints and arrests reference prostitution activity.

Deputy Sheriff [REDACTED] was one of the 'decoys' posing as a prostitute in the area of 23013 Sandalfoot Plaza Dr in the unincorporated Boca Raton, Palm Beach County FL 33428.

D/S [REDACTED] was approached by a (W/M) later identified as (ROBERT A. CRESPI) herein referred to as the Defendant, who was driving a (BLUE TOYOTA TUNDRA, BEARING FL TAG 401QDE)

Upon the DEFENDANT'S contact with [REDACTED], WHO STATED HE WANTED THE REGULAR. DEPUTY ASKED WHAT IS THE REGULAR. DEFENDANT SAID "I JUST WANT A BLOW JOB." DEPUTY STATED THE PRICE WOULD BE \$20 FOR A BLOW JOB AND THE DEFENDANT AGREED UPON THE ACT AND THE PRICE.

The predetermined signal was given and the arrest team responded from a concealed location.

[REDACTED] topped the Defendant and took him into custody without incident. The Defendant was transported to 10101 Judge Winikoff Road, where he as turned over to Corrections Deputies for processing and later transported to the county jail.

Audio and video of the transaction was captured by [REDACTED] who was conducting surveillance from a concealed location. The video of the transaction was packaged and entered into evidence by [REDACTED]. Based on the above facts, I believe probable cause exists to charge the Defendant with Offer to Commit Prostitution per F.S.S 796.07 (2)(F).
