PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 6/4/19, I was conducting routine speed enforcement in the 6000 block of Southern Blvd (SR80). I observed a large black truck travelling Eastbound at what I visually estimated to be well over the posted speed limit of 50mph. My in-car radar unit began to emit a clear and high pitched dopplar tone which is indicative of high speeds. My in-car radar display provided a true speed of 81mph in a 50mph zone. I got behind the black GMC pickup truck bearing FL tag Y87IYV, activated my emergency lights and conducted a traffic stop on the vehicle. I activated my emergency lights well before the off-ramp to Haverhill Rd. The vehicle moved over to the right as if it was going to come to a stop and then moved all the way back over to the left, crossing two lanes. While in the curb lane, I observed something thrown from the passenger window of the vehicle. The vehicle continued to Drive Eastbound almost completely to the intersection of Haverhill Rd before yielding. The vehicle finally yielded on the Eastbound off-ramp of Southern Blvd at the intersection of Haverhill Rd.

I approached the vehicle and identified the driver as W/M Robert Green by his FL Driver License. I noticed particular indicators of impairment and moved forward to a DUI investigation.

OBSERVATION OF DRIVER:

I made contact with the driver, W/M Robert Green, who was identified by his FL driver license. While requesting his documents and speaking with with Green, I could smell the clear and obvious odor of an unknown alcoholic beverage coming from his person and breath. This odor became stronger as we spoke. I could also smell the odor of marijuana coming from his person. His eyes were bloodshot and glassy. His speech was slow and thick. His movements were lethargic and slow and he had an unsteady gait while walking to my patrol vehicle.

DRIVER'S STATEMENTS:

Pre-Miranda: Stated that he had a beer earlier in the night.

Refused to participate in roadside tasks post Taylor Warnings.

ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from his person and face area which intensified as I spoke to him. I could also smell the odor of marijuana coming from his person.

GENERAL OBSERVATIONS

SPEECH: Green's speech was slow, thick, and at times difficult to understand.

ATTITUDE: Sleepy and refused roadsides

CLOTHING: Blue shirt with black shorts and red shoes.

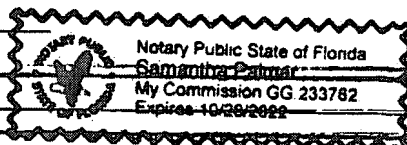

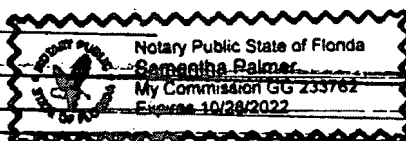
