<p>On Monday, April 17th, 2017 at approximately 2009 hours, I was dispatched to 6153 Roger St., Jupiter in reference to a disturbance. I arrived on scene and made contact with the Land Lord (W/F Joyce Petti-Albu 5/11/65). I identified myself as Officer Morgan with the Jupiter Police Department and Albu stated the following;</p> <p>Albu stated she has been having issues with a tenant (W/M Robert E. Flory 11/7/58) and tried to serve him a notice of eviction. During this time Flory became belligerent and appeared to be intoxicated. Albu stated she was concerned for Flory's well-being and needed officers to check on him. Flory is currently renting a room in the back of the residence and has not been paying rent. Albu allowed me access into the residence and stated that Flory was in the back, northwest bedroom of the house.</p> <p>I entered the house with back-up Officer Razzano and knocked on Flory's bedroom door. I announced myself as Officer Morgan with the Jupiter Police Department and asked Flory if I could speak with him. Flory unlocked his bedroom door and stated he would speak with us. I informed him, that I was there because of a verbal argument that occurred between him and his land lord as well as a welfare check on him. Flory allowed me access to his bedroom, while he explained what happened. During this time I noticed a clear plastic bag containing a green leafy substance, which I believed to be Marijuana. Flory noticed that he left the bag out and stated "oops I left my bag of weed out; you are not supposed to see that". Flory then proceeded to put the bag of Marijuana in his night stand drawer. I asked Flory if he had anything else in his nightstand and if I could check. Flory stated, "I only have my weed, I don't do any other drugs". Flory then proceeded to pull the bad of Marijuana back out of the night stand drawer. I seized the Marijuana from Flory and informed him that he was under arrest for Possession of Marijuana. The Marijuana tested positive for THC using the Marijuana quick test kit.</p> <p>Based on my investigation, the evidence and suspect's statements, I believe there is</p>
