Geaninne states that she was in judge Bronson in courtroom 6C for issuance of a permanent restraining order against Robert Mogavero case # 50-17-DR-010157-XXXX-MB .</p> <p>Geaninne states she heard Judge Bronson inform Robert that he must not speak to geaninne via phone call or verbal communication, Judge Bronson also informed Robert that he should not use text, email or through 3rd party communications.</p> <p>Geaninne states as she and her present boyfriend John existed the courtroom and waited for an elevator Robert appeared walked into an elevator and utter "is that the best you can do?". Geaninne nor John entered the elevator at that point and felt uncomfortable . Geaninne and John both provided written sworn statements.</p> <p>I then made contact with Christan .</p> <p>Christan states that while she was waiting for elevator she saw a white male enter an open elevator turn and say "is that the best you can do"? Christan states she felt uncomfortable at that moment and did not enter the elevator.
