On May 30, 2019 at approximately 0044 hours, while on patrol in the area of 200 NE 2nd St., I observed a silver Mercedes SUV with no headlights driving eastbound. I was traveling westbound on NE 2nd St. when the Mercedes turned towards my marked patrol vehicle nearly striking it. I followed the vehicle onto Plaza Real where I conducted a traffic stop on the vehicle shortly after. I activated my overhead emergency red and blue lights and the vehicle came to a stop. I approached the vehicle and the driver later identified as Robert Nersissian by his Florida driver license immediately opened the door. I closed the door and directed Nersissian to roll the window down. Nersissian was playing the stereo loudly and needed to be directed multiple times to roll the window down. Once Nersissian rolled down the window, I was overcome by a strong odor of alcoholic beverage. Nersissian was the only occupant of the vehicle. The odor of alcoholic beverage became even stronger when Nersissian began to speak. I asked Nersissian for his driver license and he initially provided me with a Florida Blue insurance card. Nersissian stated that he was coming back from "getting some soup". I asked Nersissian if he had anything to drink this evening to which he replied "soup". When I asked Nersissian if he had consumed any alcohol, he stated that he had some saki earlier but was not sure how much he had. I asked Nersissian to exit the vehicle for the purposes of conducting field sobriety tasks (SFST) to assess his ability to safely operate a motor vehicle. Once out of the vehicle, Nersissian was unsteady on his feet. I asked Nersissian if he had any medical conditions that would prevent him from completing field sobriety tasks to which he replied that he did not.
