On the above stated date and time I, [REDACTED] participated in a prostitution operation in the 3639 S. Military Trail, City of Greenacres, Palm Beach County, Florida, due to increased complaints of street level prostitution within the City of Greenacres. [REDACTED]s were posing as prostitutes in various locations throughout the city. The locations were chosen due to the citizen's complaints.

[REDACTED] was one of the "Decoys" posing as a prostitute at 3639 S. Military Trail. [REDACTED] was approached by a W/M later identified as Robert Torres who was driving a white in color Hyundai, 4-door, bearing FL tag, GVUD04.

Upon Torres making contact with [REDACTED] Torres asked how much for her. [REDACTED] stated that it depended on what he wanted. Torres informed [REDACTED] that he wanted "head from her." [REDACTED] how much he had on him. Torres stated he had \$40. [REDACTED] informed him to meet around the back of the parking lot. The predetermined signal was given and the arrest team responded from a concealed location. [REDACTED] stopped the defendant and took him into custody without incident. The defendant was transported to the PBSO staging area by [REDACTED] and [REDACTED] where he was turned over to PBSO Corrections Deputies for processing and later to be transported to the Palm Beach County Jail. Torres's vehicle was left at the arrest site per his request.

[REDACTED] of the transaction was captured by [REDACTED] who was conducting surveillance from a concealed location. The [REDACTED] of the transaction was packaged and turned into Evidence by [REDACTED]

Based on the above stated facts, probable cause exists to arrest and charge Torres with Offer to Commit Prostitution pursuant to F.S.S 796.07 (2)(F).
