PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On May 27, 2017, I was dispatched to Cobblestone Way and North Ponderosa Drive in Boca Raton FL to conduct a DUI investigation. Upon arrival, I observed a white Toyota Tundra bearing FL tag HLWG38 that was pulled over on the north side of the road. I then met with D/S William Ferel, who advised the following in a supplemental PC.

"ON THE ABOVE LISTED DATE AND TIME I WAS STATIONARY AT THE PUBLIX EXIT AT JUDGE WINNIKOFF AND PALMETTO PARK RD. WHEN I OBSERVED A WHITE TOYOTA PICK UP FL TAG HLW-G38 TRAVELLING EB IN THE #1 LANE. I GOT BEHIND THE VEHICLE AND OBSERVED IT STOP FOR A GREEN IN THE INTERSECTION AND THEN CONTINUED EB. I OBSERVED THE VEHICLE NEARLY STRIKE THE CENTER MEDIAN AND HIT MULTIPLE CENTER MEDIAN DIVIDERS. THE VEHICLE THEN TURNED INTO THE NB TURN LANE TO GO NB ON PONDEROSA FAILING TO USE A TURN SIGNAL. THE VEHICLE THEN HEADED NB AND STOPPED IN THE TURN LANE TO TURN ON COBBLESTONE FAILING TO SIGNAL. BASED UPON MY OBSERVATION OF THESE TRAFFIC VIOLATIONS I CONDUCTED A TRAFFIC STOP ON COBBLESTONE. AS I APPROACHED I ASKED THE DRIVER PUT HIS CAR IN PARK, AT WHICH TIME HE PUT THE CAR IN REVERSE AND STARTED BACKING UP TOWARD MY CAR. I LOOKED INSIDE AND HE STILL HAD THE CAR IN PARK WITH 1 FOOT ON THE GAS AND 1 ON THE BRAKE. I ATTEMPTED TO OPEN THE DOOR HOWEVER IT WAS LOCKED AND THE DRIVER WOULD NOT OPEN THE DOOR. THE DRIVER ROBER ZACHELMAYER FINALLY OPENED THE DOOR AND I PLACED HIM INTO CUFFS BASED UPON THE FACT THAT HE NEARLY STRUCK MY CAR AND THAT HE WOULD NOT COMPLY WITH MY ORDERS. I SMELLED ALCOHOLIC BEVERAGE COMING FROM HIS BREATH AND FROM HIS PERSON. I ASKED HIM IF HE HAD CONSUMED ALCOHOL AND HE STATED NO THEN YES, 1 BEER AND THEN MORE THAN 1. I ALSO ASKED HIM IF HE CONSUMED ANY PILLS HE FIRST SAID YES THEN SAID NO."

OBSERVATION OF DRIVER:

Upon my arrival on scene, I observed the defendant handcuffed to the rear due to him initially placing his vehicle into reverse and not park when the traffic stop was conducted by D/S Ferel. When D/S Ferel contact with the defendant, he had one foot on the gas and one foot on the brake pedal and was refusing to open the driver side door. The defendant was advised that this was the reason why he was placed into custody. Prior to being taken out of handcuffs, the defendant was leaning on the side of the vehicle and was not able to stand under his own power. I asked the defendant if he was willing to submit to series of roadside tasks to which he refused. I then asked again if he would be willing to submit to series of tasks and again refused. I then advised the defendant that due to him refusing roadside tasks, I would have to make a decision based on my physical observation of him as well as his driving pattern and behavior that was advised to me by D/S William Ferel. The defendant was advised that his actions could be used against him at a later date. While speaking with the defendant, he was having difficulty standing under his own power as he was leaning up against the vehicle. While speaking with the defendant, I could detect a strong odor of an unknown alcoholic beverage emitting from his breath. The defendant was speaking with a slurred, thick tongued speech and had reddened, glassy eyes.

DRIVER'S STATEMENTS:

When speaking with the defendant, I asked where he was coming from, to which he replied "home". When asked what his destination was the defendant stated "home". When repeatedly asked, as to where he was coming from or going to, the only answer the defendant could provide was home.

ODORS:

A strong odor of an unknown alcoholic beverage was emitting from the defendants breath. As I began to speak with the defendant, the obvious odor became even stronger. Once the defendant, was placed into the rear of D/S Levey's marked patrol vehicle, there was a odor now present in the backseat of the vehicle, which was not there previously.

GENERAL OBSERVATIONS

SPEECH: Slow, Slurred, Thick Tongued,

ATTITUDE: Calm, Cooperative

CLOTHING: White T Shirt, Swimming Trunks, no shoes.

MEDICAL/OTHER: **All roadside tasks were attempted to be conducted on in car video. The defendant stated that he was a diabetic. Palm Beach County Fire Rescue 58 run number 17- 058744, responded and determined that the defendant was not having a diabetic episode.
