Officer O'Brien prepared a photo array using the photo of Robert Radloff as well as the photos of 5 other random individuals who matched the description. The photo array was presented to Murray by Jupiter Police Officer Janine Ercolano, ID#1079. Murray was unable to make an identification from the array.

Officer O'Brien called Robert Radloff to try to schedule a meeting to get his statement. He stated that he was at work all day and that his vehicle was with him all day. Radloff also stated that he would be willing to come to the Palm Beach Gardens Police Station but only after speaking with his attorney.


Officer O'Brien's interactions with Mall Security, Michael Murray as well as the phone conversation with Radloff were all recorded using her agency issued body worn camera. The footage was later uploaded to Evidence.com.

Upon being assigned the case on 02/22/2018, I contacted Michael Murray to inform him that I would be investigating the case. I asked him about the extent of his injuries and he stated that he sustained a compound fracture to his right wrist that required surgery. He said that his wrist was broken in 6 different places and required 9 screws and 1 titanium plate to correct. I also went over the events that took place at the Gardens Mall.

Murray stated that he was driving into the Gardens Mall from one of the south side entrances. He said that a white vehicle cut him off, so he proceeded to "lay on his horn". He then observed as the driver of the white vehicle lowered the window and pointed at the mall. Murray stated that he thought the driver was trying to let him know that he was trying to get to the mall. Murray then parks his vehicle in the same parking lot he normally parks since he works at Macy's. Once he parked his vehicle, he observed a white male walking over to his vehicle. He then gets out of the vehicle and before he can even say a word, the White male violently pushes him causing him to fall onto the concrete floor. The white male then walks back to the white vehicle and drives away. I asked Murray if he has ever seen the white male before and he said no.

I then proceeded to call Robert Radloff to schedule a meeting to go over the incident and to obtain his sworn statement. Radloff stated that he did not wish to speak with me and that I should contact his attorney Brian Gabriel (561-622-5575). He stated that his attorney advised him to not talk to law enforcement and to wait for a summons in the mail. I called the attorney and left a message.

On 02/23/2018 at approximately 2:05pm, I received a call from Attorney Brian Gabriel. I explained to Gabriel that I needed to speak with Radloff regarding the incident at the mall due to the victim being hurt and having to get surgery. Gabriel stated that he was under the impression that there was an incident at the mall involving Radloff but that nobody was hurt. He stated that he would need to speak with his client again and that he

would call me the following week.

On 02/27/2018, I called Gabriel to discuss our previous conversation. He advised that due to his client possibly being charged with a felony, he recommended his client not to come talk to me or provide a statement.

On 03/02/2018, I went to the Mercedes Benz dealership located at 9275 ALT A1A, North Palm Beach, Florida 33403 where Robert Radloff works. I spoke to general manager Arthur Diaz. He stated that Radloff has been working at the dealership for over 6 years. I asked him if he could provide me the time card for Radloff on 02/20/2018. He provided me with the timecard for the entire week. The time card shows Radloff clocking in every morning and clocking out at the end of the day. It does not show Radloff clocking out for lunch all week. Diaz stated that he is dealing with an issue where some of the employees are not clocking out for lunch and that it is being handled internally. He said that although the time card shows Radloff not clocking out, it is very possible that he does leave for lunch and was not at work during the incident.

On 03/15/2018 I returned to the Mercedes Benz dealership located at 9275 ALT A1A, North Palm Beach, Florida 33403. I made contact with Arthur Diaz who is the general manager for the dealership as well as Shawn Potsander who is the service manager and overlooks the department where Robert Radloff works in. I showed him the video surveillance footage from the mall and he appeared surprised. After looking at all the videos of the incident and photos of the vehicle, Potsander stated that in his opinion, there is no doubt in his mind that the person shown in the video pushing the victim is Robert Radloff. He recognized the vehicle and even stated that the clothing matched the work uniform worn by his employees.

My entire interaction with Arthur Diaz and Shawn Potsander was recorded using my agency issued body worn camera. The footage was later uploaded to Evidence.com

Due to the results of my investigation and statements from all parties involved, I find probable cause to charge Robert Radloff DOB:02/12/1984 with BATTERY-AGGRAVATED CAUSE BODILY HARM OR DISABILITY contrary to F.S.S 784.045 (1) (A) (1).

All information for this case will be forwarded to the Palm Beach County State Attorneys Office for review.
