On the 13 day of March, 2018 at 07:56 (Specifically include facts constituting cause for arrest.)

On March 13, 2018 at approximately 0625 hours, I was dispatched to the Northfork Dr near Longshore Dr in reference to a suspicious vehicle on the side of the road. The caller advised he ran by a dark colored vehicle which appeared to be running on the side of the road. Upon arrival, Officer Juric located a young male sleeping in the vehicle. I walked up to the passenger side and observed a light skinned male, later identified as Roberto Furfaro, with his legs and rear end in the driver's seat. His upper body was laying over the center console with his head in the passenger seat. The keys were in the ignition, engine running. I could hear the radio, which was on inside the vehicle. Furfaro was not disturbed by the flashlights at all.

I opened the passenger door and attempted to wake him. I immediately smelled the smell of an unknown alcoholic beverage. I announced was the police and tapped the seat and he did not stir at all. Officer Juric opened the driver door and immediately noticed a bag of green leafy substance, which by her training and experience she knew to be marijuana, in the driver's door compartment. Officer Juric and I called out to him several times with no results. Officer Juric shook his feet and he began to wake up. He exited the vehicle and said began speaking unintelligibly. He used his car of balance. His eyes were bloodshot and glassy. I asked what was going on with him and he said "Austin and Max". He was extremely confused and disoriented. He said "he aint driving" and pointed to the back seat of the vehicle. Furfaro was the only occupant of the vehicle. Officer Juric asked him for his ID or driver's license and went back into his car and retrieved a broke cellphone which had no charge. He said "I thought it did licensing in things and then muttered something unintelligible". I asked him where he was coming from and he said "they bowling kinda lateish". I asked him if he had anything to drink and he said "no, I didn't even care". I asked him if he knew what time is was and he said "1230". It was 0630 hours. He gave his information to Officer Juric who then asked Northcom to do a computer check on him. I asked him how old he was and he said "19 or 20ish". He said he did not have anything to drink. I advised him I thought he was impaired and asked him

if he was willing to submit to roadside tasks and he said "yes". I patted him down for weapons and found none.

I asked Furfaro to walk across the street to a nearby sidewalk so that I could safely conduct roadside tasks and he complied. He did very poorly on roadside tasks and was subsequently arrested for DUI (see DUI roadides form). He asked several times for a breathalizer and wanted to know why he was being arrested. I explained to him he was being arrested for DUI and possession of marijuana. He said he understood.

I searched his vehicle incident to arrest and found an empty bottle of Angry Orchid cider in the back left seat. I located a clear zip lock baggie for a green leafy substance in the driver door. I recognized the substance, from my training and experience, as marijuana. I located a small amount of the same substance in the center console.

Furfaro asked me again why he was being arrested and I explained it to him. He said the marijuana charge he understood and told me the bottle I found in the back of his car was not his. He told me a story about the two female friends he dropped off at their homes, but his directions did not make sense. Furfaro was very chatty and talked at length about many things.

We arrived at the Palm Beach County Breath Testing facility at 0735 hours. I conducted a 20 minute observation period of Furfaro where he did not regurgitate or take anything by mouth. Furfaro submitted two samples of his breath, a 0.177 and a 0.177.

Based on the above mentioned investigation, there is probable cause to believe Furfaro was in actual physical control of a motor vehicle while impaired, contrary to FSS 316.193(1). There is also probable cause to believe Furfaro did possess a controlled substance, marijuana under 20 grams, contrary to FSS 893.13(6) (B). He was turned over to the Palm Beach County Jail without incident.

WALK & TURN:

Said "I understand" while I was still giving instructions. Missed heel to toe on steps 1, 3. Did not begin counting out loud until step 4. Took 10 steps and stepped off the line on step 10. Furfaro stopped in the middle of the turn, as if he believed he completed the task. I reminded him to take 9 steps back. He stepped on his toe on returning step 2, missed heel to toe on step 3, stepped off the line on step 4, stumbled and nearly fell over on step 5, took 3 more steps missing heel to toe and declared "this is the first time I've ever done this in my life".

ONE LEG STAND:

Furfaro began the task before being told to do so. He lifted his right foot only a few inches off the ground. He looked straight at me and I had to remind him to look down at his foot. He placed his foot down after 15 seconds and said "oh shit". He picked his foot back up and began counting again. He was swaying the entire task.

FINGER TO NOSE:

Interrupted me to tell me he understood while I was still giving instructions. Initially closed his eyes when he tilted his head back but opened them after bringing the first finger to his nose. Had to be reminded to close his eyes. Touched the tip of his nose using the pad of his finger on all fingers. Touched above his lip on the last right. Furfaro kept his eyes open the entire time, even after being reminded to close them.

ROMBERG ALPHABET:

Furfaro advised he was in college. I asked him if he was comfortable with the English alphabet and he said "yes, well, that part no". I asked what he meant and he said "I can't do it backwards, I can try for you". I told him he did not say anything about saying the alphabet backwards. I gave him the instructions and he said he understood. I told him to begin when he was ready and he asked "backwards?" I told him "no, just normal". He said "ok". He began "XYZ". I told him not to do it backwards, just normal. He said "oh, ok". He then restarted saying "XYZ" he mumbled several letters unintelligible "ZYXWTUVRSV...TUV... ZRSW... TUV... WTV... LMNOP... so, OMNOP... LMNOP... so, PLMNO... LMNO ...that gets half of it out so I'm almost done... LMNOPQRSTUVWXYZ".
