On 5/21/17 at 1314 hours Officer Susan Eisenreich responded to activity A17-006353.1 located at 5543 Boynton Place in Boynton Beach, Florida in regards to picking up three kittens that had reportedly scratched the complainant named Bonnie Lackey.

Officer Eisenreich made contact with Bonnie Lackey who mentioned that her neighbor located at 5536 Boynton Place had a long haired dog that was currently outside in the backyard and nobody was home with the animal. Due to the weather Officer Eisenreich decided to look into the information as the neighbor's backyard appeared to be in full sun.

As Officer Eisenreich approached 5536 Boynton Place she could hear what sounded like a kitten crying. Through slotting in the defendant's fence Officer Eisenreich observed a gray plastic bucket with a blue recycle bin turned upside down on top of the bucket. Officer Eisenreich believed the kitten was located in the bucket.

According to the website Weather Underground ([www.wunderground.com](http://www.wunderground.com)) the temperature outside at 12:53pm was 84.9 with a heat index of 88.2. Officer Eisenreich advised in her report that she read 85 degrees as the outside temperature on her cell phone's weather application.

Officer Eisenreich made contact with Roberto Poli at the front door of his residence located at 5536 Boynton Place. After Officer Eisenreich asked Roberto Poli about the kitten inside of the bucket, Mr. Poli admitted to placing two kittens into the bucket. Roberto Poli stated that he was tired of cats coming onto his property as it had been happening for years.

Roberto Poli advised that he had observed two kittens in his driveway earlier in the morning and moved them back to Bonnie Lackey's property. The kittens then reportedly returned to Mr. Poli's property so he placed them in a bucket. When Officer Eisenreich asked Roberto Poli what time he had placed them in the bucket, Mr. Poli advised Officer Eisenreich that it was 4:30am.

Roberto Poli escorted Officer Eisenreich to the backyard of his property. Officer Eisenreich detailed in her report that after entering Mr. Poli's backyard she observed the recycle bin on top of a bucket. Mr. Poli removed the recycle bin and a plastic lid was observed on the bucket. Once the lid was removed two kittens were observed laying in the bottom of the bucket.

Officer Eisenreich described the two kittens as appearing wet and breathing heavily with open mouths. The smaller kitten appeared too weak to move and was lying flat. Roberto Poli reportedly tried cooling the kittens down with water before Officer Eisenreich removed the animals.

Both kittens (1872855 female kitten and 1872856 male kitten), were transported back to ACC by Officer Eisenreich for on staff veterinarian Dr. Dacia Oprisanu to evaluate. Dr. Dacia Oprisanu advised that the female kitten was minimally responsive at its arrival at ACC with wet fur and severe dehydration. The female kitten had a body temperature of 91.3 degrees Fahrenheit. A normal temperature for the kitten would have been between 99-101 degrees Fahrenheit. Due to the kittens presented state and lack of response to treatment, Dr. Oprisanu elected to have the female kitten humanely euthanized to prevent further suffering.

The male kitten appeared in better health and had a body temperature of 100.3 (within normal range). Dr. Oprisanu notated that the male kitten had a decreased appetite for the first week of its care while at ACC and did not start eating on its own until 5/30/17.

Dr. Oprisanu wrote the following in her animal cruelty report: "Heat stroke can occur in animals left in closed spaces without protection from high environmental temperatures and those that are debilitated have been found to be more susceptible to its effects.

Methods by which heat can be dissipated from a body include convection, where air flow will remove much of the heat, conduction, which refers to the exchange of heat between two bodies that are in contact with each other, radiation in which heat is lost through infrared rays, and evaporation.

In this case where the two kittens were found in a covered bucket there would be minimal, if any, air flow occurring so the built-up heat would have no way of escaping.

Responses to this would include panting or open-mouth breathing (noted by the Animal Control Officer on scene), postural changes to assist in heat liberation from the individual, an increase in respiratory rate, vasodilation of vessels in the skin, and a lack of appetite".

When most reasonable people would have contacted ACC and secured an unwanted kitten somewhere safe, Roberto Poli opted to do neither. Roberto Poli admitted to placing both kittens inside of a bucket because he was tired of cats coming on his property. Officer Eisenreich observed the kittens in distress with open mouth breathing. One kitten had to be euthanized due to its condition and the other did not begin eating on its own for 9 days, which are consistent with heat stroke. Based on the above facts; probable cause exists to charge Roberto Poli with two counts of animal cruelty F.S.S. 828.12 and two counts of animal cruelty F.S.S. 828.13 Confinement of animals without sufficient food, water, or exercise; abandonment of animals.


