I was dispatched to an allegation of domestic battery that occurred at 6429 MARBLETREE LN in unincorporated Lake Worth in Palm Beach County, Florida.

When I arrived on scene I made contact with the Victim, Daniel Tigan who made the following statements: He was arguing with his wife, Rodica Tigan at the above address. They both had been drinking and the argument escalated. Rodica then went to Daniel's mother's room and began removing her blanket from her person. Daniel stated that Rodica was yelling at his mother while removing the blanket. He took her intentions to be aggressive in nature so he pushed her away from his 82 year old mother. He then stated as he and Rodica exited his mother's room, she punched him in the face which resulted in his lip bleeding. I observed a small cut on Daniel's lip.

I interviewed Rodica and post Miranda warning she made the following statements: Daniel had come home drunk from a bar. They got into an argument about her shaving the dog. Daniel then escalated the argument by talking poorly to her and her mother who is 84 years of age. Rodica went to Daniel's mother to get her attention so that she could hear Daniel's behavior. She said as she was removing the blanket from Daniel's mother, he came over and shoved her which resulted in her being scratched on the chest. She stated she then punched him in the mouth afterwards.

Due to the statements made by both parties, my investigation led me to believe that Rodica is the primary aggressor. Daniel observed what he felt was a potential threat to his elderly mother and sought to remove Rodica from her because they both were involved in a heated argument. Rodica then struck Daniel with a closed fist to which he retreated and called 911 because his intent was not to harm her but remove her from what he perceived as a threat to an elderly person's safety.

Daniel refused to fill out a Victim's statement in reference to this case.
