On Saturday 1/21/17 at approximately 0145hrs I responded to [REDACTED] subdivision in unincorporated Boca Raton in reference to a domestic dispute. I had previously been to the residence earlier in the night for a domestic dispute reference case number: [REDACTED].

Upon arrival I spoke with the victim [REDACTED] who completed a sworn written statement and told me the following: [REDACTED] stated that after I left the residence [REDACTED] Rodney got into another verbal argument. [REDACTED] told me that the argument took place [REDACTED]. [REDACTED] stated that during the argument Rodney [REDACTED] using two hands and he also [REDACTED] with an open palm. [REDACTED] stated that [REDACTED] and called 911. I did not observe any visible marks or injuries to [REDACTED]'s person.

I then spoke to Rodney who stated that after we left the residence he and [REDACTED] got into another verbal argument. Rodney stated that [REDACTED] tried to get into [REDACTED] drinking. Rodney told me that he tried to take the keys out of [REDACTED]'s vehicle and [REDACTED]. I observed scratch marks on Rodney's chest and the back of his head. [REDACTED] and Rodney both stated that they had been drinking alcohol and both were noticeably intoxicated.

Based on my investigation I determined Rodney to be the primary aggressor. I have probable cause to charge Rodney with Domestic Battery F.S.S. 784.03 (1a1). I advised Rodney that he was being placed under arrest for Domestic Battery. I then placed Rodney in handcuffs to the rear. The cuffs were double locked and checked for proper fit. I then placed Rodney in the rear of my marked patrol vehicle and transported him to CJ without incident.
