The below incident occurred in the Town Of Highland Beach, Palm Beach County State of Florida. This Officer Responded to 3301 South Ocean Blvd 3801 in reference to a Domestic Incident, that had just occurred. This Officer made contact with W/F Jaclynn Dempsey at the noted location. I observed Ms. Dempsey in a very distraught mood, shaking and having difficulty speaking. Ms. Dempsey was holding her left arm as well as rubbing the back of her neck. The room and conversation with Ms. Dempsey was recorded on my Body worn Camera. The subject the male companion of Ms. Dempsey had fled the property prior to our arrival. The male who Dempsey currently lives with is Rodney Robinson Blake Jr. 11-26-1940 I observed the residence with a broken glass table, a wooden statue that was on the ground under the dining room table that was broken as well as various items in the living room that had been thrown on the floor. Ms. Dempsey stated that the night prior they had gone out for dinner when she saw and spoke with an old acquaintance of hers, Blake at this time became very jealous and an argument ensued. On arrival at the condominium parking lot the argument escalated with Blake pulling Dempsey out of the car by her hair. Blake reportedly continued this into the elevator and up to the 8th floor of the condominium(Ambassador East). Blake continued to pull her by the hair up to the apartment as she yelled for help. One unknown person observed this action, but refused to help. Dempsey stated that he had left for the night and returned at about 0800 hours. The argument began again with Blake reportedly hitting Dempsey in the back of the neck with the wooden statue. Blake then reportedly attempted to strangle Dempsey by wrapping his arm around her neck with Dempsey resisting and biting Blake on the arm, she could not say for sure what arm. Blake wanted to take a shower with Dempsey refusing to let him into the bedroom due to several firearms being in the room. He then broke the thick glass kitchen table by unknown means, threw Dempsey to the ground and left the residence. A resident who requested to be anonymous stated that they both heard the commotion but didn't know what to do. The 8th floor resident stated that this happens quite often with this couple. Delray Fire Rescue responded to treat Ms. Dempsey. Fire Paramedics evaluated Dempsey's left elbow that had a visible bruise as well as a small abrasion to her back. Dempsey was transported to Delray Medical center for further treatment This officer attempted to make phone contact with Blake with messages being left on Blakes cell phone. Due to the above facts, This officer believes Probable Cause Exists to have Defendant Charged with, Aggravated Domestic Battery FSS 783.03(2)
