MEDICAL/OTHER: refused to answer

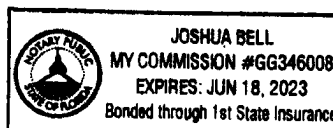

Other Observations:

No resting nystagmus. VGN present. LOC present. Unsteady gait. Swaying. Watery and glassy eyes. Onset around 30 degrees.

WALK & TURN:

Could not maintain the instructional stance. Did not walk heel to toe on all steps. Used his arms to balance. Stepped off the line at almost every steps.

ONE LEG STAND:

Initially stopped the task on the count of 5. When reminded to continue until told, he restarted the count and lowered his leg on the count of 5, 8, 11, 12. He swayed, used his arms to balance, and hopped.

FINGER TO NOSE:

Used the pad of his fingers at every step. Swayed. Lowered his head. On all tasks he touched the side of his nostrils instead of the tip of his nose.

ROMBERG ALPHABET:

Swayed. Tilted his head forward. Could not complete the alphabet despite restarting multiple times and singing it.

BREATH TEST RESULTS: refused

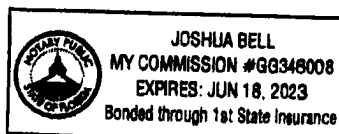
