Ofc Lopez stated he observed the vehicle, a black Chevy pickup truck bearing FL tag BHIY29, make an illegal change of lanes from the southbound on ramp lane into the northbound on ramp lane. Whitman appeared disheveled and groggy. Whitman's eyes would close slightly while he was speaking with me. I observed that Whitman had blood shot and glassy eyes.

Whitman stated that he was fishing all day with his nephew. Whitman said that he had 3 or 4 beers while fishing on a boat. When I asked Whitman where he was coming from he told me that he was going home from Jupiter. Throughout the investigation Whitman repeatedly asked if we could talk about this.

ODORS:

I could smell a strong odor of an unknown alcoholic beverage coming from Whitman.



Other Observations:

During the HGN Whitman swayed while standing in place. Whitman at times would not be looking where instructed and had to repeatedly told to keep his head still.

WALK & TURN:

Whitman could not stay still and in the position I instructed him to stay in while I gave instructions. Whitman would also sway back and forth during the instructions. Whitman attempted to begin the task without being told to start. On steps 2, 8 and 9 he stepped off the line and lost his balance. Whitman raised his arms several times to balance himself, most noticeable on steps 2, 4 and 8. Steps 2, 4, 6, 8, 9 he did not touch heel to toe. Whitman did not turn as instructed. On returning step 2 Whitman stepped off the line with his right foot.

ONE LEG STAND:

Whitman had a hard time keeping his feet together and had to be told to keep feet completely together. While I was giving instructions Whitman raised his arms away from his side and crossed them. At the count of "1009" Whitman put his foot down on the ground and raised his arms to balance himself. Whitman counted to "1010" with both feet on the ground and then paused. I had to remind Whitman that he was to continue until I instructed him to stop. Whitman stated he didn't know how long he had to do it for. Whitman counted to 1015, lost his balance and placed his foot on the ground.

FINGER TO NOSE:

Whitman was swaying while standing in the instructed position. L1 he touched the bridge of his nose with the side of his finger. R1 he touched the side of his nose with the tip of his finger. L2 he touched the bottom of his nose with the side of his finger. R2 touched the side of his nose with the tip of his finger. R3 he touched the side of his nose with the tip of his finger. L3 he touched the bottom of his nose with the tip of his finger.

Whitman was swaying while standing in the instructed position. Whitman stated the following A, B, C, D, E, F, G, H, I, J, K, L, M, N, O, P, Q, R, S, T, U, V, W, X, Y, Z.


