






N A R R A T I V E	<p>I met with Price, who appeared upset and had a small abrasion on her finger. According to Price she went to The Duck Tavern with her boyfriend, Rommel Damiani, whom she had been in a romantic relationship for several years. Price stated Damiani was upset with her all night and was talking bad about her to her friend Tammy. Price advised that on the way home from the bar, they continued to argue in the car. Price stated that Damiani pushed and shoved her while he was driving, telling her to get out of his vehicle. Price told Damiani to just take her home. Damiani then stopped his vehicle in the roadway at approximately the 2400 block of NW 2nd Ave and got out of the driver seat, walked around to the front passenger side door, and began to pull Price out of the vehicle by her arms. Price advised that Damiani shoved her and then drove south on NW 2nd Ave. It should be noted that Price did appear intoxicated and at times had slurred speech. I took photos of Price's injuries on scene, which were placed into BRPD evidence. Price had a small abrasion with dried blood on her left middle finger. Price also had a small bruise on her left upper thigh area that she advised was from rough sex with Damiani the other day. Price provided Damiani's address and Officers responded over to 1234 SW 5th St to make contact with him. Price stated she was too upset and did not want to provide a written statement at this time, but stated she would come to the police department in the morning and provide one.</p> <p>Officer Saavedra, Officer Galazka, Officer McCabe and Officer Miller met with Rommel Damiani at 1234 SW 5th St. I responded to their location, where I spoke with Damiani. According to Damiani, he was "set up" by his girlfriend, Lisa Price, tonight. Damiani explained that he agreed to go to The Duck Tavern with Price. They met up with two of Price's friends, Tammy and Jill, and had a couple drinks. Damiani advised they began to argue, at which point he told Price that it was time to go and he was going to take her home. Damiani explained that on the way home Price hit him while he was driving and he stopped the car and told her to get out. Price refused to get out of the vehicle. Damiani continued to drive until approximately the 2400 block of NW 2nd Ave. Damiani state he pulled off of the roadway into a driveway, got out of the vehicle, opened Price's door and pulled her out of the vehicle. Damiani stated he quickly got back into his vehicle and drove home. I did not observe any injuries on Damiani.</p> <p>After speaking with both parties, I determined that Rommel Damiani was in violation of F.S.S 784.03(1a1) Battery (Domestic) after he intentionally touch Price against her will when he pulled her out of the vehicle.</p> <p>Damiani was placed under arrest and transported to BRPD where he was processed and transported to Palm Beach County Jail. While at the BRPD Damiani wished to provide a written statement, which was placed into BRPD evidence.</p>
