On May 25th, 2018 the Boynton Beach Police Department was conducting a reverse prostitution operation in the 2700 block of S. Federal Hwy, located within Boynton Beach. The operation was specifically focusing on the Atrium Plaza and the Homing Inn area.

Ofc. R. Moccia, in an undercover capacity as a female prostitute, was standing in front of Atrium Plaza (2755 S. Federal Highway). At approximately 2025 hours, a male, later identified as w/m Ronald Verbit, made contact with Ofc. R. Moccia. The two engaged in conversation, at which time Verbit offered Ofc. Moccia \$10.00 for a "BJ" (a common terminology for oral sex).

The prearranged takedown signal was given and officers moved in and placed Verbit under arrest. Post Miranda, Verbit did not agree to speak with officers.

Based on the aforementioned, I found that there was probable cause to charge Verbit with soliciting another to commit prostitution, according to FSS: 796.07.2F. He was processed and turned over to the PBCJ.
